The RBI pegged auto loan portfolio growth in the gross bank credit till November 7, 2023, at 20.8 per cent with an outstanding portfolio of ₹5,64,785 crore.

Once the full quarter is taken into account, it might surpass last year's growth of 22 per cent, say bankers.

ICICI Bank, for instance, has an instant car loan disbursement, an industry-first proposition, for pre-approved customers; the delivery order is generated digitally in a seamless manner.

HDFC Bank, too, is offering an entirely digitally-driven process for new auto loans.

"Regarding IDBI Bank, there will be certain due diligence processes, and there will be a financial bid. And so I don't think that it will be possible in the first half," Pandey told businessline.

As of December 31, 2023, LIC holds 49.24 per cent, while the government has 45.48 per cent in IDBI Bank. In the strategic divestment of IDBI Bank, the preliminary information memorandum (PIM) for

Rapido extends zero commission model to auto drivers

Rapido has announced that it is extending its Software-as-a-Service (SaaS)-based zero-commission model to auto drivers. In the new model, auto drivers will be able to receive

zero-commission payments from the customer in exchange for a dynamic fee to the platform. Rapido plays no role in deciding the price point, making the service transparent and inclusive for all stakeholders, the company said in a statement.

Pavan Guntupalli, co-founder of Rapido, told businessline, "Captains won't be charging a commission on their rides, and instead, they will have to pay a daily login fee ranging from ₹5 to ₹29 to the platform. They can do as many rides as they want and retain 100 per cent of their earnings. The range of the daily login fees will be specific to each city."

This model will initially hamper Rapido's profitability, Guntupalli said. "But the goal is to have an impact-first result that will help establish a sustainable business model wherein the increase in fleet size and the number of rides will result in increased revenue and long-term viability."
