We wish to inform you that the Board of Directors of the Company, have vide resolution(s) passed by circulation approved the following:

- a. Allotment of 4,89,251 equity shares of Rs. 2/- each at a premium under Dhanvarsha ESOP Plan 2018. Details pertaining to the same are tabulated in Annexure I (Part A); and
- b. Allotment of 2,87,500 equity shares having face value of Rs. 2/- each at a premium of Rs. 78/- per share upon conversion Compulsorily Convertible Debentures (CCDs). Details pertaining to the same are tabulated in Annexure I (Part B).
