In terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that the Company has yesterday i.e. on 24th June, 2024 at about 05:00 p.m. (IST) received Orders under the provisions of Section 129 of the State Goods and Services Tax Act, 2017 read with relevant provisions of the Central Goods and Services Tax Act, 2017 and the rules made thereunder, from the GST Authority. The Company intends to file an appeal against the said Orders within prescribed timelines.

Nature and details of the action(s) taken, initiated or order(s) passed	The Authority had detained the vehicles carrying certain goods to the project site arbitrarily alleging "Goods not covered by valid documents and are being transported without support of a valid E-way bill". The goods were accompanied with all valid necessary documents (except E-way bill validity which had expired in view of ongoing Covid-19 pandemic in FY 2020-21). After securing release of goods and vehicles, the Company had simultaneously filed appeal before appellate authority, which was rejected vide exparte orders received by the Company on 24 th June, 2024. The authority has demanded to pay an aggregate tax amount of INR 12.98 lakhs along with penalty of INR 12.98 lakhs.
