# **WHO** declares monkeypox a global emergency

**ASSOCIATED PRESS** London, July 23

THE CHIEF OF the World Health Organisation said the expanding monkeypox outbreak in more than 70 countries is an "extraordinary" situation that now qualifies as a global emergency, a declaration Saturday that could spur further investment in treating the once-rare disease and worsen the scramble for scarce vaccines.

WHO Director-General Tedros Adhanom Ghebreyesus made the decision to issue the declaration despite a lack of consensus among members of WHO's emergency committee. It was the first time the chief of the UN health agency has taken such an action. "We have an outbreak that has spread around the world rapidly through new modes of transmission about which we understand too little and which meets the criteria in the international health regulations," Tedros said."I know this has not been an easy or straightforward process and that there are divergent views among the members" of the committee,
