राष्ट्रीय जांच एजंसी की अवालत ने असम में संशोधित नागरिकता कानुन के खिलाफ हिंसक प्रदर्शन पापले में सिवसागर के विधायक अखिल गीगोर्ड के खिलाफ गैर कानूनी गतिविधि (रोकथाम)अधिनियम 1967 के तहत दर्ज दो मामलों में से एक में उन्हें आरोपों

से वरी कर दिया है। विशेष एनआइए न्यायाधीश प्रांजल दास ने गोगोई के खिलाफ आरोप तम नहीं किए। गोगोई को दिसंबर 2019 मैं चाबुआ पुलिस थाने में दर्ज मामले में गिरफ्तार किया गया था। अदालत ने गोगोई के दो सहयोगियों – जगजीत गया था। अवस्तित न गांगाई के दा सहत्यागया - अग्याता गोहित एयं भूंचेन गोंगाई को भी मामले में मेर कानूनी गतिव्विध ग्रेकचाम अधिनियम के सभी आरोगों से बरी कर दिया। रायजीर दल के अध्यक्ष गोंगांचे को चाबुआ पुलिस थाने में कर्म कुत मामले में इससे फरले जानूना मिल गई थी। यह मामला बाद में एनआइए को सींप दिया

गया था। गोगोई के खिलाफ एनआइए दो मामलों की जांच कर

रहा है, जो शुरूआत में चांदमारी एवं चाबुआ पुलिस थानों में दर्ज कराए गए थे। यह मामला हिस्क प्रदर्शन में गोगोई एवं उनके तीन अन्य साथियों की कथित भूमिका के लिए दर्ज किया गया था। गोगोई के तीसरे सहयोगी दजा कथा गया था। गागाइ के तासर सहयागा भारकरज्योति पुक्तन के खिलाफ आरोप तय किए गए, लेकिन ये आरोप यूएपीए के तहत नहीं बल्कि भारतीय दंड संहिता की घारा 144 (घातक हथियारों से लैस होकर गैरकानूनी तरीके से एकत्रित होना) के तहत तथ होकर प्रिरकानुनो तरीके से एकिकित होना) के तहत ताय किए गए है। इस मामले को डिब्रुगढ़ के मुख्य न्याविक मिकान्ट्रेट की अदालत में स्थानांतरित कर दिया गया है। उच्च न्यापालय में जमानत की अर्जी खारिज हो जाने के बाद गोगोई ने उच्चतम न्यायालय का करवा किया। उच्चतम न्यायालय ने इस तरा पर इस अर्जी पर विचार करने से इनकार कर दिया। गोगोई को 12 दिसंबर 2019 को जोरहार से गिरफार किया गया था। उस रोया प्रयोश में जोशिकत व्याधिकता श्रीधियान का विशेष पर ने जैसे पर में संशोधित नागरिकता अधिनियम का विरोध पूरे जोरी पर था। गोगोई की गिरफ्तारी कानून व्यवस्था के महेनजर एहतियात के तौर पर हुई थी और इसके अगले दिन उनके तीन सहयोगियों को हिरासत में लिया गया था।
