We could understand that there was an exuberant buying spree between 28th of January 2022 the date on which the share price of Lotus Eye Hospital And Institute Limited hit the 52 week high of Rs.59.10 per share till the 02nd of February 2022 were the shares touched an all time high of Rs. 71.35 per share. We further came to know that the number of sellers during the specified point of time was miniscule.

In our understanding the increase in share price is due to factors unknown to us which has resulted in share price touching an all time high of Rs 71.35 per share on 02nd February 2022.

We undertake further that trading in shares of Lotus Eye Hospital And Institute Limited was not carried out by any of the insiders or designated persons who are either in possession of or privy to the Unpublished Price Sensitive Information (UPSI).
