I, Harinath Punna, Partner of M/s H&A Associates LLP, Practicing Company Secretaries were appointed as Scrutinizers, to scrutinize and to ascertain the requisite majority, on the resolutions proposed to be passed through the remote e-voting process as well as the e-voting facility (collectively referred to as "e-voting facility") provided to the members under the provisions of Section 108 and any other applicable provisions of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended and read with the Ministry of Corporate Affairs ("MCA") General Circular No. 14/2020 dated April 08, 2020, Circular No.17/2020 dated April 13, 2020 and Circular No. 20/2020 dated May 05, 2020 (collectively referred to as "MCA Circulars") and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") read with SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 ("SEBI Circular") issued in this regard.

Service Provider

1. The Company has availed the services of Central Depositories Services (India) Limited (CDSL) for facilitating e-voting to enable the members to cast their votes electronically using remote e-voting system as well as e-voting during the AGM on all the items of the business(es) (Ordinary as well as Special) transacted at the AGM of the Company.

Management's Responsibility

2. The Management of the Company is responsible to ensure the compliances with the requirements of the Companies Act, 2013 read with rules made thereunder, SEBI Listing Regulations, the MCA Circulars and the SEBI Circular or any other provisions, as applicable for the AGM of the Company. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

Scrutinizers' Responsibility

3. Our responsibility as Scrutinizers for the e-voting facility is restricted to make Scrutinizers' Report of the votes cast "For" or "Against" the resolutions stated in the Notice of the AGM dated September 04, 2020. Based on the reports generated from the e-voting system provided by the service provider i.e. (CDSL) and documents furnished to us electronically by the Company and/or CDSL for our verification.

Notice in electronic mode

4. The notice for AGM was sent to all the Members/Beneficiaries electronically on September 07, 2020, whose e-mail IDs were registered with the Company or Depository Participants in accordance with the provisions of the Companies Act, 2013 read with Rules made thereunder together with the MCA and SEBI Circulars. Further, the notice for AGM was available on the website of the Company and on the websites of BSE limited ("BSE"), Stock Exchange where Company's shares are listed.

Cut-off date

5. The Members of the Company as on the "cut-off date" for e-voting facility i.e. Friday, September 18, 2020 were entitled to avail the e-voting facility on the proposed resolutions (Item nos. 1 to 3) as set out in the Notice of the AGM.

Remote e-Voting process

6. The remote e-voting period remained open from Thursday, September 24, 2020 at 9.00 A.M. (IST) and ended on Monday, September 28, 2020 at 5.00 P.M. (IST) on the designated website https://www.evotingindia.com of CDSL.

Newspaper Advertisements

- 7. Pursuant to applicable provisions of the MCA Circulars, the Company had published the advertisement in English in "Business Standard" newspaper having wide circulation dated September 03, 2020 and in Telugu in "Navatelangana" newspaper dated September 03, 2020.
- 8. Pursuant to Rule 20 of the Companies (Management and Administration Rules) 2014, as amended, the Company had published the advertisements in English in "Business Standard" newspaper having wide circulation dated September 07, 2020 and in Hindi in "Navatelangana" newspaper dated September 07, 2020.

E-voting at the AGM

9. At the AGM of the Company held through VC/OAVM on Tuesday, September 29, 2020, after considering all the items of business, the facility to vote electronically was provided to those members who were attending the meeting through VC/OAVM but could not participate in the remote e-voting process to cast their votes.

After the closure of e-voting at the AGM, the e-voting conducted at the AGM and the remote e-voting conducted prior to the AGM were unblocked and were downloaded in the presence of two independent witnesses, Ms. Puli Akshitha and Mr. Satyendra Teeka, who are not in the employment

of the Company. The Votes casted by the members were reconciled with the records maintained by M/s. Venture Capital and Corporate Investments Private Limited), the Registrar and Transfer Agent of the Company.
