This is to inform you that the Board of Directors of the Company, at a meeting today, i.e. on July 16, 2021 inter-alia considered and approved the sale of the entire stake held by the Company in One Mobikwik Systems Limited (*erstwhile One Mobikwik Systems Private Limited*). 1,39,440 equity shares with a face value of Rs. 2/- each are being sold at Rs. 905/- per equity share to Spark Fund Advisors LLP (“**Purchaser**”). The entire transaction is for Rs. 126,193,200.

The transaction shall be completed in tranches; in the first tranche today, the Company has sold 69,720 equity shares (50% of the holding) today.
