In terms of the provisions of The Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR") and The Companies Act, 2013 ("Act"), and circulars dated May 5, 2020, April 13, 2020 and April 8, 2020 issued by the Ministry of Corporate Affairs ("MCA Circulars") and Circular SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 and Circular No. SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 and General Circular no 19/2021 dated 08.12.2021 and General Circular no. 21/2021 dated 14.12.2021 and General Circular no 02/2022 dated 05.05.2022 and General Circular no 10/2022 and 11/2022 dated 28.12.2022 issued by the Securities and Exchange Board of India ("SEBI Circulars") the Company hereby informs the following:

1. Pursuant to section 96 of the Act and Regulation 30 of the SEBI LODR and in compliance with the MCA Circulars, the 37th Annual General Meeting ("AGM") of the Company will be held on Wednesday, 20th September, 2023 at 11:30 A.M. through Video Conferencing (VC) to transact the business as set forth in the Notice of 37th AGM;

In compliance with the MCA Circulars and SEBI Circulars, owing to the difficulties involved in dispatching of physical copies of the Notice of the 37th AGM along with the Annual Report for the financial year 2022-23 will be sent only through electronic mode to those shareholders whose email addresses are registered with the Company/ Depositories/ Registrar and Share Transfer Agent of the Company.

- Pursuant to Regulation 42 of SEBI LODR, the Register of Members and Share Transfer Books of the Company will remain closed from Thursday, 14th September 2023 to Wednesday, 20th September, 2023 (both days inclusive) for the purpose of 37th AGM of the Company;
- 3. Pursuant to MCA Circulars and Section 108 of the Act read with the Companies (Management and Administration) Rules, 2014, as may be amended from time to time and pursuant to the Regulation 44 of the SEBI LODR, the Company has appointed Link Intime India Private Limited ("LIIPL") for the providing remote e-voting facility and participation in the AGM through VC to the members of the Company. The remote e-voting facility shall commence on Sunday, 17th September, 2023 at 9:00 A.M. and ends on Tuesday, 19th September, 2023 at

- 4. The Company has appointed Mr. Naresh Samkaria, Partner of Samkaria & Associates, as the scrutinizer to scrutinize the remote E-voting as well as the voting process at the AGM through VC in a fair and transparent manner.
- 5. This was approved in Board Meeting held on Thursday, August 24, 2023.
