We wish to inform you that the 119th Annual General Meeting (AGM) of the Company was held on Tuesday, September 05, 2023 at 11:30 AM through video conference. Pursuant to Section 108 of the Companies Act, 2013 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the company had provided remote e-voting facility to the Members entitled as on the cut-off date i.e. 28/08/2023 to cast their vote at the 119th AGM electronically on the items of business as stated in the AGM Notice. The Company has opted the services of National Securities Depository Limited (NSDL) as the agency to provide Remote e-Voting facility and E-voting Facility during the 119th AGM. The remote e-voting commenced on 01/09/2023 (9.00 a.m.) and ended on 04/09/2023 (5.00 p.m.). The company had also provided e-voting facility during the AGM and the e-voting window was kept open 15 minutes after the conclusion of the AGM for the members who had not casted their votes on Remote E-voting.

M/s. PRS Associates was appointed as the Scrutinizer for the 119th AGM by the Company. The Company has now received the report of the Scrutinizer confirming the details of voting through remote e-voting and details of e voting at the AGM. Accordingly, as per the said Rules, on account of passing of resolutions with requisite majority, the resolutions as stated in the AGM Notice dated May 16, 2023 are deemed to be passed on the date of the AGM i.e. September 05, 2023.

A copy of the Scrutinizer's consolidated report on remote e-voting and e-voting at the AGM is enclosed and the same is also being placed on the website of the Company and NSDL.

1. Appointment as a Scrutinizer

We were appointed as the Scrutinizer for the remote e-voting as well as the e-voting by Members during the 119th Annual General Meeting ("AGM") of **Hindoostan Mills Limited** (hereinafter referred to as "**the Company**") scheduled on Tuesday, the 5th September, 2023 at 11:30 A.M held through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM"). Our responsibility as a Scrutinizer was to ensure that the voting process was conducted in a fair and transparent manner and submit a Scrutinizer's report on the voting on the resolutions based on the reports generated from the electronic voting system.

2. The compliance with the provisions of the Companies Act, 2013 and Rules made thereunder and MCA and SEBI circulars relating to voting at the AGM by the Shareholders on the resolutions set out in the Notice of the 119th Annual General Meeting of the Company is the responsibility of the Management.

My responsibility as a Scrutinizer of the voting process (through E-voting) was restricted to scrutinize the E-voting process in a fair and transparent manner and to prepare a scrutinizer's report of the votes cast in favour and against the resolutions stated in the Notice, based on the reports generated from the E-voting process provided by NSDL, the service provider.

3. Dispatch of Notice convening the AGM

- a) Pursuant to General Circulars No. 14/2020, 17/2020 and 20/2020 dated 8th April, 2020, 13th April, 2020 and 5th May, 2020 and General Circular No. 02/2021 dated 13rd January, 2021, MCA Circular no. 2/2022 dated 5th May, 2022 and MCA Circular no. 10 /2022 dated 28th December, 2022 respectively issued by the Ministry of Corporate Affairs, an advertisement was published in Free Press Journal (English) on 8th August, 2023 and Navshakti (Marathi) on 8th August, 2023 specifying the date & time of the AGM, availability of the notice on Company's website and website of the Stock Exchange (BSE Limited), manner of registration of E-mail-Ids by the members (both physical and demat) who are yet to register their Email Ids with the Company, manner of voting through remote e-voting or through e-voting system at the AGM etc.
- b) The company hosted the notice of AGM on its website, website of the agency providing the platform for remote e-voting i.e. NSDL and e-voting during the AGM and also intimated the same to BSE Limited on 7th August, 2023.
- c) The company informed that on the basis of the Register of Members and list of Beneficial Owners made available by Computech Sharecap Limited, the Registrar and Share Transfer Agents (RTA) of the Company and the depositories i.e. National Securities Depositories Limited (NSDL) and Central Depositories Services (India) Limited (CDSL) respectively. The company completed dispatch of Notice of AGM on 7th August, 2023 by email to 3985 Members who had already registered their email ids with the company / Depositories.

4. Cut-off Date

Voting rights were reckoned as on Monday, **the 28th August, 2023**, being the cut-off date for the purpose of deciding the entitlements of members for remote e-voting and e-voting at the AGM.

5. Remote e-voting process

a) Agency

The Company appointed National Securities Depository Limited (the "NSDL") as the agency for providing the platform for remote e-voting as well as e-voting at the AGM.

b) Remote e-voting period



Remote e-voting platform was open from 9:00 a.m. (IST) on Friday, the 1st September, 2023 till 5:00 p.m. (IST) on Monday, the 4th September, 2023 and members were required to cast their votes electronically conveying their assent or dissent in respect of the resolutions on the remote e-voting platform provided by NSDL.


- c) The Company had also provided remote e-voting facility to the shareholders present at the AGM through VC / OAVM and who had not cast their vote earlier.

6. Voting at the AGM


- a) In keeping with Regulation 44(1) and 44(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and as prescribed under Rule 20 (4)(xiii) of the Companies (Management and Administration) Rules, 2014 for the purpose of ensuring that Members who have cast their votes through remote e-voting do not vote again during the Annual General Meeting, the Scrutinizer shall have access after closure of period of remote e-voting and before the start of general meeting, to only such details relating to Members who have cast their votes through remote e- voting, such as their names, DP ID & Client ID / folios, number of shares held but not the manner in which they have voted.
- b) Accordingly, NSDL, the remote e-voting agency provided us with the names, DP ID & Client ID / folios and shareholding of the members who had cast their votes through remote e-voting.

7. Counting Process

- a. On completion of e-voting during the AGM, we unblocked the results of the remote e-voting in the presence of Mr. Sanjay Shringarpure and Ms. Raksha Shetty who acted as witness as prescribed in Sub Rule 4 (xii) of the said Rule 20 and e-voting by members at the AGM, on the NSDL e- voting platform and downloaded the results.

- b. Based on the aforesaid results, we report that Three (3) Ordinary Resolutions as set out in item Nos.1, 2 and 3 of the Notice of the AGM dated 16th May, 2023 have been passed with requisite majority.
