We wish to inform you that the Board of Directors of the Company, at their meeting held today, i.e, on Monday, 17th June 2024, approved the following:

- 1. Appointment of Shri Dinanath Kholkar (DIN: 03089626) as an Additional Non-Executive Independent Director on the Board of the Company with effect from 17th June 2024, for a period of 5 years. The above appointment is based on the recommendation of the Nomination and Remuneration Committee of the Company. Further, Shri Dinanath Kholkar has confirmed that he meets the criteria of 'independence' under Section 149 of the Companies Act, 2013 and Regulation 16 of the Listing Regulations and is not debarred from holding the office of Director by virtue of any order passed by Securities and Exchange Board of India (SEBI) or any other such authority.
