Sub: Notice of Rescheduling of Board Meeting and closing of Trading Window.

Dear Sir/Madam,

With reference to our earlier letter dated July 22, 2020, regarding intimation of date of Board Meeting, which was scheduled to be held on Thursday, July 30, 2020, to approve inter alia Audited Financial Results for the quarter and year ended March 31, 2020, we hereby inform you that meeting of the Board of Directors of Tokyo Plast International Limited Ltd. ("the Company") is being postponed and rescheduled to 13th August, 2020.

Considering the present circumstances in relation to extended lockdowns due to COVID-19 it is very challenging for the Company and its management to prepare financial statements of the Company as our office is situated in Containment zone, all the employees are working from home and even some of our employees are in quarantine center which has made the situation even worse. Also, the audit process has become difficult for our auditors as they are in Mumbai and our Registered office is at Daman.

We have also sent a request letter to SEBI for extention of time as we are not in position to declare Audited Financial result as of now.

In this connection, in continuation to the earlier disclosure relating to the Trading Window of the Company, which is currently close from April 1, 2020 on account of declaration of Annual Audited Financial Results, shall continue to remain close till 48 hours after the declaration of Unaudited financial results for the Quarter of financial year 2020-21 ended on 30th June, 2020.


