दुष्यंत को किसानों ने दिखाए काले झंडे

चंडीगढ़, 18 जून (जनसत्ता)।

केंद्र सरकार द्वारा पारित तीनों कृषि कानूनों के विरोधस्वरूप आंदोलनरत किसानों ने आज हरियाणा सरकार में उप-मुख्यमंत्री दुष्यंत चौटाला को हिसार में और खेलकूद एवं युवा मामलों के मंत्री संदीप सिंह को भी आज शुक्रवार काले झंडे दिखाए। किसान हिसार हवाई अड्डे के समीप जमा हो गए थे जब उन्हें उप-मुख्यमंत्री के आने की भनक लगी थी। नारेबाजी करते हुए किसानों ने उन्हें काले झंडे दिखाने शुरू कर दिए।

दुष्यंत वहां अपनी नानी कांता देवी की मृत्यु के बाद नानके में शोक व्यक्त करने एक परिजन

के घर भी गए थे। उधर, यमुनानगर में किसानों ने पहले ही खेलकूद मंत्री के खिलाफ धरना-प्रदर्शन करने की घोषणा कर दी थी और प्रदेश में जारी धान रोपाई के बावजूद बड़ी संख्या में किसान वहां जमा हो गए थे। किसानों के संभावित विरोध को देखते हुए पहले ही भारी पुलिस बल मौके पर तैनात किया गया था। लेकिन इसके बावजूद किसान अवरोधकों को लांघते हुए लघु सचिवालय पहुंच गए। पुलिस कर्मी उन्हें आगे बढ़ने से लगातार रोकते रहे लेकिन किसान सरकार विरोधी नारे लगाते हुए आगे बढ़ते रहे।

भाकियू के जिलाध्यक्ष सुभाष गुर्जर का कहना है कि किसान आधे घंटे तक लघु सचिवालय के सामने डटे रहे जब मंत्री वहां अंदर बैठक में

शिरकत कर रहे थे। संदीप सिंह को आज यमुनानगर में जिला जन संपर्क एवं शिकायत निवारण बैठक में हिस्सा लेना था। गुर्जर ने कहा, 'क्या वजह है कि मंत्री किसानों की व्यथा नहीं सुन रहे जो बीते सात महीनों से सड़कों पर बैठने को विवश हैं। भाजपा-जजपा नेताओं के खिलाफ हमारा धरना प्रदर्शन यूं ही आगे भी जारी रहेगा।'

गुर्जर ने यमुनानगर नगर निगम के मेयर मदन चौहान के भी विरोध प्रदर्शन की पुष्टि करते हुए बताया कि उस समय चौहान लघु सचिवालय में एक बैठक के लिए जा रहे थे। एक वीडियो में नजर आ रहा है कि आंदोलनकारी किसान मेयर के कार चालक को वाहन पीछे मोड़ने के लिए उकसा रहे थे जबकि पुलिस कर्मी रोक रहे थे।
