Toll Revenue for Q4FY19

Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 7.3% to Rs. 2,810.9 mn in Q4FY19 from Rs. 2,620.0 mn in Q4FY18.

ARRIL- Toll revenue received (excluding car) in Q4FY19 has increased by approx 3.3% to Rs. 253.4 mn from Rs. 245.3 mn in Q4FY18.

AJTL - Toll revenue (excluding cars and state buses) received in Q4FY19 has increased by approx 3.9% to Rs. 106.2 mn from Rs. 102.2 mn in Q4FY18.

BHTPL - Toll revenue received in Q4FY19 has reduced by approx 6.6% to Rs. 298.0 mn from Rs. 318.9 mn in Q4FY18.

HYTPL - Toll revenue received in Q4FY19 has increased by approx 13.1% to Rs.202.9 mn from Rs. 179.3 mn in Q4FY18.

MBCPNL-Toll revenue received in Q4FY19 has increased by approx 16.2% to Rs.573.4 mn from Rs. 493.5 mn in Q4FY18. During Q4FY19, 18 Check Posts were generating revenue for full quarter while during Q4FY18, 16 Check Posts were generating revenue for full quarter and 2 more Check Posts commenced revenue generation.

DPTL - Toll revenue received in Q4FY19 has increased by approx 2.7% to Rs. 487.6 mn from Rs. 474.7 mn in Q4FY18.

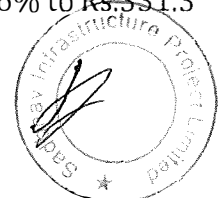
RPTPL- Toll revenue received in Q4FY19 has reduced by approx 19.1% to Rs. 234.6 mn as against Rs. 290.0 mn in Q4FY18.

SUTPL- Toll revenue received in Q4FY19 has increased by approx 26.6% to Rs.331.3 mn as against Rs. 261.7 mn in Q4FY18.

RHTPL - Toll revenue received in Q4FY19 has increased by approx 18.2% to Rs.177.6 mn as against Rs. 150.3 mn in Q4FY18.
