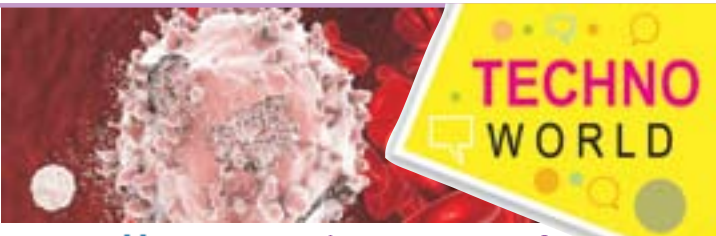

हिन्यांनी संपन्न उल्केचे उलाढले रहस्य!

२००८ मध्ये सुदानमध्ये हिन्याच्या खनिजाने संपन्न अशी एक उल्का कोसळली होती. या उल्केचे गूढ उकलण्यात आता संशोधकांना यश आले आहे. अमेरिकेतील टेक्सासमधील साऊथवेस्ट रिसर्च इन्स्टिट्यूटमधील संशोधकांनी म्हटले आहे की, ही उल्का एका लघुग्रहाचा भाग असून हा लघुग्रह तुलनेने आकाराने मोठा आहे. तो इतका मोठा आहे की त्याचा आकार जवळजवळ सेरेस या खुजा ग्रहाइतका आहे.

'नासा'ने सर्वप्रथम या उल्केचा छडा लावला होता. या उल्केचा व्यास तेरा फूट तर वजन ८,२०० किलो होते. या उल्केच्या ५० ग्रॅम भागाचे इन्फ्रारेड मायक्रोस्कोपखाली संशोधन करण्यात आले. त्यामधून असे दिसून आले की, या उल्केमध्ये अनेक खनिज रचना आहे. कोलॉरॅडोमधील बोल्टर येथील साऊथवेस्ट रिसर्च इन्स्टिट्यूटमधील विकी हॅमिल्टन यांनी सांगितले की कमी तापमान व कमी दाबाखाली, पाण्याच्या संपर्कात येताच या उल्केमधील खनिजे दिसून येतात. एरव्ही अनेक उल्कांमधील खनिजे ही उष्णता दिल्यावर पाण्याच्या राहिल्याच्या अवस्थेत दिसून येतात. आता सापडलेली ही उल्का 'हिरा' या कार्बन खनिजानेही संपन्न असल्याचे दिसून आले आहे. यापूर्वी काही लघुग्रहांवरही यान पाठवण्यात आले आहे. अलीकडेच जपानचे 'हायाबुसा-२' हे यान 'र्युगु' या लघुग्रहावरील खडकांचे नमुने घेऊन परतले असून 'नासा'चे 'ओसिरिस-रेक्स' हे यान बेन् लघुग्रहावर उतरले होते.



ब्लड कॅन्सरवर औषध सापडले ?

भारतवंशीयाचा समावेश असलेल्या शास्त्रज्ञांच्या एका पथकाने ब्लड कॅन्सर व बोन मॅरो कॅन्सरवरील उपचाराबाबत महत्त्वपूर्ण यश मिळविले आहे. या पथकाने असे एक औषध विकसित केले आहे की, ते कॅन्सरच्या वरील दोन्ही प्रकारांवर उपयुक्त ठरणार आहे. तसेच हे औषध कॅन्सरच्या आणखी काही प्रकारांवर उपचारासाठी उपयोगी ठरू शकण्याची शक्यता आहे, असे या शास्त्रज्ञांनी म्हटले आहे.

ब्लड कॅन्सर डिस्कव्हरी नामक पत्रिकेत यासंबंधीचे संशोधन प्रसिद्ध करण्यात आले आहे. गेल्या दशकभरापासून सुरु असलेल्या या शोधामुळे उपचाराचा एक नया आणि प्रभावी पर्याय उपलब्ध होण्याची शक्यता आहे. या औषधामुळे ल्यूकेमिया सेल्सबरोबरच टीईटी-२

म्युटेशनचा सफाया करण्यात यश मिळू शकते. हे महत्त्वपूर्ण संशोधन अमेरिकेतील प्रसिद्ध क्लिवलँड क्लिनिकचे संशोधक जेरोस्लाव मॅकीएजेवस्की आणि बाबल कांत यांचा समावेश असलेल्या पथकाने केले आहे. जेरोस्लेव यांनी नव्या संशोधनाबाबत माहिती देताना सांगितले की, प्रिव्हिजनिकल मॉडेलच्या आधारावर करण्यात आलेल्या संशोधनात असे आढळून आले की, 'टीईटीआई ७६' नामक सिंथेटिक मॉलिक्यूल हे कॅन्सर कोशिकांचा खात्या करण्यास पूर्णपणे सक्षम आहे. या मॉलिक्यूलमध्ये कॅन्सरच्या प्रारंभिक अवस्थेतील व पूर्णपणे विकसित झालेल्या स्थितीतील कोशिकांचा खात्या करण्याची क्षमता आहे.

बॅटरीवर चालणारा ट्रॅक्टर

उत्तर प्रदेशातील बारावीच्या एका विद्यार्थ्याने बॅटरीवर चालणारा ट्रॅक्टर बनवला आहे. या पर्यावरणपूरक ट्रॅक्टरने इंडिया इंटरनॅशनल सायन्स फेस्टिव्हलमध्ये पहिले स्थान मिळवले आहे. तीन तासांमध्ये हा ट्रॅक्टर एक एकर शेताची नांगरणी करू शकतो. राहुल सिंह असे या तरुण वैज्ञानिकाचे नाव आहे.

छपरा गावातील सोळा वर्षांचा राहुल गोरखपूरच्या एबीसी पब्लिक स्कूल दिव्यनगर येथे बारावीत शिकतो. तो मदनमोहन मालवीय प्रौद्योगिकी विश्वविद्यालयाच्या डिझाईन इनोव्हेटर अँड इन्व्हेन्शन सेंटरमध्ये संशोधक म्हणून काम करतो. तो तीन वर्षांपासून सातत्याने इंडिया इंटरनॅशनल सायन्स फेस्टिव्हलमध्ये पहिले स्थान पटकावत आला आहे. २०१८ मध्ये रोटी मेकर, २०१९ मध्ये बॅटरीवर चालणारी इको-फ्रेंडली सायकल आणि यावर्षी कोरोनाच्या संकटकाळातही त्याने बनवलेल्या बॅटरीवरील ट्रॅक्टरला हे पहिले स्थान मिळाले आहे. राहुलने म्हटले आहे की, हा ट्रॅक्टर पूर्णपणे इको-फ्रेंडली आहे. बॅटरीवर चालत असल्याने त्याचा आवाज होत नाही. डिझेल-पेट्रोलसारखे जीवाश्म इंधन यामध्ये वापरले जात नसल्याने प्रदूषण होत नाही. हा ट्रॅक्टर ताशी ७० किलोमीटर वेगाने धावू शकतो. राहुलने स्वतःच या ट्रॅक्टरची बॅटरी आणि मोटरही बनवली आहे हे विशेष. ही बॅटरी वेगळ्या मार्गाने चार्ज करण्याची गरज भासत नाही. ट्रॅक्टर सुरु झाला की ती आपोआपच चार्ज होत राहते.
