




Financial Performance for the Quarter & Half Year ended 30th September, 2020.

- Profit before Tax (PBT) for H1FY21 stood at Rs. 91.06 crore and Profit after Tax (PAT) stood at Rs. 58.42 crore for H1FY21.
- Fresh Loans of Rs. 350 crore sanctioned and further disbursements of Rs. 334 crore has been made during the quarter.
- Further Loan Sanction of structure debt facility of Rs. 550 crore to integrated renewable energy projects and loans of Rs. 80 crore for refinancing operational solar projects in Q3FY21 till date.
- Fresh long term credit lines of Rs. 700 crore and in-principle / LOI for credit lines of Rs. 150 crore received during Q2FY21.
- Long Term to Short Term Liability ratio at comfortable level of 91: 9 as at 30th September, 2020.
- Capital Adequacy ratio stood at 24.06% as at 30th September, 2020.

Management Commentary:

As the second quarter of the Financial Year 2020-21 has concluded, we are happy to announce that the Company's continued to demonstrate its resilience on all performance / operational parameters. This has been possible by facing the challenges, drawing effective strategies and marching with determination. Considering the current scenario, the result has been extremely satisfying. The net profit stands at Rs. 32 crore, with an improvement in our net interest margins to 3.58%. With much needed liquidity boost, we are now increasing our focus on lending towards sustainable infrastructure projects, renewables, HAM annuity projects, waste management, sewage treatment plants, gas distribution and electric vehicle charging. Safe to say, the consolidation phase of the Company is now over and we are looking ahead towards a future of resurgence, expansion and growth. Our priority towards maintaining a clean balance sheet, both in terms of nature of business and quality of assets, remains untethered. We strive to improve our NIMs, Cost of Borrowings and all Operating Margins, to position the Company for sustainable growth.

- Profit before Tax (PBT) for H1FY21 stood at Rs. 91.06 crore compared to Profit before Tax (PBT) of Rs.91.55 crore in H1FY20.
- Profit After Tax (PAT) stood at Rs. 58.42 crore in H1FY21 compared to Profit After Tax (PAT) of Rs.59.88 crore in H1FY20.
- Yield on Earning Assets stood at 11.37% in H1FY21.
- Net Interest Margin on earning portfolio stood at 3.52% in H1FY21 compared to Net Interest Margin of 3.25% in H1FY20.
- Business (disbursements) of Rs. 434 crore has been made in H1FY21.

As at 30th September, 2020

- The total outstanding credit i.e. aggregate of loan assets and non-fund based commitments against sanctioned loans, stood at Rs. 11,638 crore as on 30th September, 2020. Loan assets aggregated to Rs. 11,194 crore and outstanding non-fund based commitments aggregated to Rs. 444 crore.
- Gross Non Performing Accounts (GNPA) stood at 8.46% and Net NPA at 4.74% as at 30th September, 2020.
 Company is expecting further reduction in its NPA level in coming quarters with resolution of few of its stress accounts.
- Capital Adequacy Ratio as at 30th September, 2020 stood at 24.06% comprising Tier I at 23.32% and Tier II at 0.74%.
- $\circ~$ Debt to equity ratio has reduced to 4.30 times.
- The cost of borrowing for the quarter ended 30th September, 2020 stood at 8.53%.
