Brief proceedings of the 46th Annual General Meeting:

The 46th Annual General Meeting (AGM) of the Members of Steel Strips Infrastructures Limited ('the Company') was held on Saturday, September 28, 2019 at 11.00 A.M (IST) at Village Somalheri/Lehli P.O. Dappar, Tehsil Derrabassi, Distt. S.A.S. Nagar Mohali (Punjab)-140506. Shri Sanjay Garg, chaired the meeting. The requisite quorum being present, the Chairman called the meeting to order. Shri Surinder Singh Virdi (Independent Director, Chairman of Audit Committee & Nomination and Remuneration Committee) and Smt. Manju Lakhanpal (Independent Director and Chairman of Stakeholders Relationship Committee) were also present in the meeting.

The Chairman informed the shareholders that the Company had provided Members the facility to cast their vote electronically, on all resolutions set forth in the Notice. Members who were present at the AGM and had not cast their votes electronically were provided an opportunity to cast their votes at the end of the meeting.

It was further informed that there would be no voting by show of hands. Ms. Deepika Gupta, Company Secretary, read the Auditors' Report.

- 2) Appointment of Shri Humesh Kumar Singhal (DIN: 00044328) as Director, who retires by rotation and is eligible for re-appointment.
- 3) Approval for Re-appointment of Sh. Surinder Singh Virdi (DIN-00035408), Independent Director for a second consecutive term of five years.
- 4) Approval for Re-appointment of Smt. Manju Lakhanpal (DIN-07130592), Independent Director for a second consecutive term of five years.
- 5) Approval for Appointment of Sh. Surinder Kumar Bansal (DIN-00165583) as Independent Director for a period of five years.

Clarifications were provided to the queries raised by the members.

The Board of Directors appointed Sushil K. Sikka as the Scrutinizer to supervise the e-voting and poll process. The Chairman authorized the Company Secretary to declare the results of voting and place the same on the website of the Company.
