Dear Sir/ Madam,

In respect to our earlier intimation dated 22nd October, 2024 on the captioned matter this is to inform you that the actual date of closure of wholly-owned subsidiary Company, Kanplas Do Brasil Ltda, Brasil was 2nd September, 2024.

We would like to clarify that as per the intimation letter issued by the concerned department of the Company of Brasil the actual date of closure of Company was 2nd September, 2024. However, by mistake the date of closure was earlier reported as 21st October, 2024, this was the date we came to know about the closure of Subsidiary Company.

The mistake was due to miscommunication from the administrator appointed in the subsidiary company in Brasil and non availability of closer letter from the concerned department. We encountered some delays in obtaining the official confirmation regarding the closure of the company which led to this error. Copy of the closure letter issued by the Ministry of Finance at Brasil is attached herewith for your ready reference and records.

We appreciate your understanding in this matter and are committed to ensure timely and accurate communications in the future while dealing with foreign subsidiary companies, if any. Other content of the intimation dated 22nd October, 2024 are unchanged.
