The Stock Exchanges were informed earlier at various stages regarding approval of the Cabinet Committee on Economic Affairs (CCEA) in its meeting dated January 06, 2016, for closure of three Subsidiary Companies of HMT Limited i.e., HMT Watches Limited, HMT Bearings Limited & HMT Chinar Watches Limited.

In this regard, the Board of Directors of the Company in its meeting dated 03rd November, 2022 has reviewed the status of the closure of HMT Watches Limited, wholly owned Subsidiary Company and has approved (subject to approval of the shareholders) for taking over of the legal cases of HMT Watches Limited by HMT Limited along with Contingent Liabilities & also Transfer of Immovable assets of HMT Watches Limited to HMT Limited at book value in order to ensure early closure of HMT Watches Limited.

Subsequently, HMT Limited shall continue with the activity of disposal of land of HMT Watches Limited and transfer the sale proceeds to GOI/Ministry of Heavy Industries in line with the approval of Cabinet Committee of Economic Affairs (CCEA) after deducting the applicable taxes and related expenses. This is in line with the directions received from Ministry of Heavy Industries.
