मुंबई : जैविक विविधतेचे योग्य प्रकारे व्यवस्थापन होण्यासाठी मुंबई महानगरपालिकेच्या स्तरावर 'जैविक विविधता व्यवस्थापन समिती' गठीत करण्यात आली असून, त्या समितीमध्ये लोकप्रतिनिधींसह तज्ज्ञांचाही समावेश करण्यात आला आहे. उद्यान विभागाचे उपायुक्त रमाकांत बिरादार यांच्या अध्यक्षतेखाली झालेल्या सभेत 'जैविक विविधता व्यवस्थापन समिती'चे सदस्य सचिव म्हणून उद्यान अधीक्षक जितेंद्र परदेशी यांच्याकडे जबाबदारी सोपविण्यात आली आहे. या समितीमध्ये सात लोकप्रतिनिधी, मुंबई महापालिकेचे आठ खातेप्रमुख व पाच तज्ज्ञ सदस्य, तसेच विशेष निमंत्रित म्हणून सत्ताधारी २५ शाळांमध्ये ही प्रयोगशाळा पक्षाचे एक खासदार व एक आमदार यांचा स्रूक्त करण्याचा निर्णय घेण्यात आला समावेश आहे.
