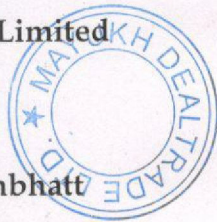

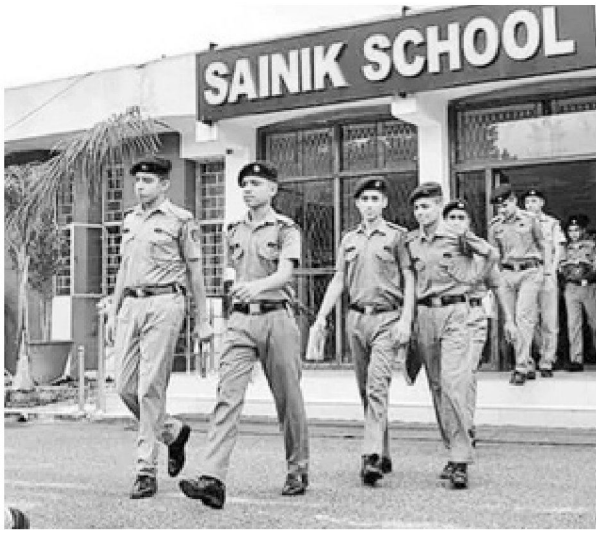

# More Sainik Schools on the anvil

# Vishwajoyt to reopen schools; creates a safe & interactive learning environment with the hybrid model in the 'new normal' world

PRAYAGRAJ : Students who wished to attend a Sainik School but were unable to do so due to the lack of such a school in Prayagraj would soon be allowed to do so. The process of establishing a Sainik School in Sangam city has begun, according to authorities from the state education department. In last year's budget, the central government, in collaboration with the Sainik Schools Society, approved a proposal to establish 100 new Sainik Schools across the country, compared to only 33 already in operation in India.



These new schools will be established under the public-private partnership (PPP) model with the goal of developing the ethos of national spirit, indomitable courage, an unwavering commitment to values of respect for country and society, imbuing the importance of physical fitness, and embodying national pride in students, while providing a quality educational environment by involving government/private schools in establishing and aligning their system with Sainik Schools? eco-system. "Those, whether organisations or investors, who are interested in opening these schools can visit https://sainikschool.ncog.gov.in and apply," Prayagraj district school inspector of schools (DioS) RN Vishwakarma said.

Government-aided schools such as Kendriya Vidyalaya Sangathan, Navodaya Vidyalaya Sangathan,

autonomous schools, schools directly operated by the Ministry of Defence and Railways, public sector schools, and private schools are eligible to apply under the plan. According to the plan, around 5,000 students will be enrolled in the schools during the 2022-23 academic year. The schools will begin accepting students in the sixth grade. These schools will operate in the same manner as the other 33 Sainik Schools located throughout the country. The government will

also provide financial assistance to these schools in the form of fees, training grants, and so on. In exchange, the government will profit from the previously established infrastructure in reputable private and public schools. The project is designed to fulfill the increasing demand for Sainik Schools.

These Sainik Schools will also have the option of allowing day scholars to attend classes from early morning to late evening, allowing day scholars to participate in full-day academic and extra-curricular activities. Teachers at the proposed Sainik School will receive teacher training through the Sainik Schools Society. Each Sainik School will be required to excel in an identified sport in accordance with the ministry of sports and youth affairs 'One School? One Sport' system. Furthermore, NCC vacancies will be filled in accordance with current policy, according to officials.

Mumbai : Vishwajoyt High School announces return to full-time, face-to-face instruction with its innovative model of education after the Government of Maharashtra's Department of School Education and Sports gave its consent to reopen schools from the 24th of January, 2022. The school has also been transforming the educational landscape since the Covid-19 outbreak with its hybrid education model to safeguard students whose learning has been impacted severely in the 'new normal.' With the aim of providing students in-person instructions with COVID-19 preventative measures in place, Vishwajoyt has been putting into practice its innovative & interactive hybrid form of education that enables students to have the option to continue remote instruction using a self-paced learning software. Where schools are using technology and sending out pre-recorded videos or simply broadcasting the live class without interaction for online students, Vishwajoyt has created a fully interactive immersive experience so that students can experience the content delivered fully while training the teachers and giving them the technology to interact with both sets of students, those attending in-person classes and those attending online classes.

This model was introduced keeping in mind concerns from a section of parents who still felt uncomfortable sending their children to schools.

"Vishwajoyt High School in Kharghar has gone beyond the generic norms of online education. Our hybrid model is invested in providing our students a stellar education experience so that they can learn to do their best ability by using both online and offline modes of education," said Amrut Dhupal, Co-Founder at Vishwajoyt Schools. "This system is also flexible in a way that as the students start feeling comfortable, they can opt for in-person teaching. This model ensures that the students/parents do not feel pressured and allows them to make the right decision without worrying about the loss of learning," says Amrut. Preventative measures for in-person instruction include mandatory mask-wearing, socially distanced classrooms, plexiglass barriers to separate students or staff members where appropriate, no shared supplies, and frequent cleaning and sanitation of classrooms, bathrooms, and cafeterias, among other things. The high school adheres to a SOP (Standard Operating Procedure) which aligns well with the SOP provided by the Maharashtra government. The high school

is focused on maintaining the sanitation, security, and safety of the children, and has a checklist for each of their schools to ensure the same. "The roadmap to safely reopen schools for in-person learning is forged by ensuring transparency and building trust with the parenting community, starting with the safety standards and resources needed to keep everyone in our schools safe," said Prasad Dhupal, Co-Founder at Vishwajoyt Schools. "We have developed reopening plans by remaining cognizant to the education community, including teachers, and they are based on scientific standards that minimize COVID-19 transmission in schools. Teachers. Parents and school staff understand that there can never be an adequate substitute for in-person learning and that reopening schools is vital for our children's well-being and education, but in-person learning must be safe for everyone," says Prasad. For thorough planning, the opinions of parents and guardians were taken through forms and webinars. It was found that in Lonand and Phaltan districts of Satara, roughly 85% of parents wished their children to have physical learning. While in Kharghar, Navi Mumbai, 30% of parents expressed their desire for in-person classes.

## BJP MP Ravindra Rai recounts horrifying experience of attack on him in Bokaro



Ranchi : After the attack in Bokaro during the movement of Jharkhandi Bhasha Sangharsh Samiti, former MP Ravindra Rai became offensive against the state government. In a press conference in

state BJP headquarters in Harmu today, former state minister Rai said that during the attack he visualized a scene before mob lynching and somehow managed to save his life. He said his

bodyguards were in the most trouble and somehow saved his life by running into the police station. Rai said that the incident showed how people are being cheated through power by spreading darkness in the political corridors of Jharkhand. "After the formation of Jharkhand, first attempt was made to create tension in Bokaro itself and then an attempt was made to break the social fabric on Sunday. Hundreds of miscreants were on the streets in the name of the movement of Jharkhandi Bhasha Sangharsh Samiti," Rai added.
