नवी दिल्ली : दिल्लीच्या सोमेवर असलेल्या राय्यामध्ये मातशेतीचे खुंट जाळण्याचे प्रकार तातडीने थांबवत पाहिले, असे आदेश सर्वोच्च न्यायालयाने मंगळवारी दिले. 'ही जनतेच्या आरोग्याची हत्या आहे. यशियाव दुसरे कोणतेही शब्द माझ्याकडे नाहीत,' अशा शब्दांत न्या. संजय किशन कोल यांनी राजधानी दिल्लीतील प्रदूषणावरून यंत्रणांवर ताशेरे ओढले.

नोव्हेंबरच्या पहिल्या आठवड्यात शेत जाळण्याच्या घटनांमध्ये ३५ टक्के वाढ झाली असून त्या १२ हजारांपर्यंत पोहोचल्या आहेत. दिल्लीच्या शेजारील राज्यामध्ये शेत जाळण्याच्या घटनांमुळे गेल्या काही दिवसांपासून दिल्लीच्या हवेतील प्रदूषणाने अतिशयतक पातळी गाढली असून मंगळवारी शहराच्या अनेक भागांमध्ये हवेच्या गुणवत्ता निर्देशांकांने ४०० ची पातळी ओलांडली होती. तापमानातील घट व वाऱ्याच्या वेगात वाढ आणि पाऊस या तीन घटकामुळे दिल्लीतील प्रदूषण कमी होऊ शकते. दिवाळीनंतर पावसाची शक्यता हवामान खात्याने वर्तवली असल्यामुळे आणखी आठवडाभर दिल्लीकरांची घुसमटीतून सुटका होण्याची शक्यता नाही.
