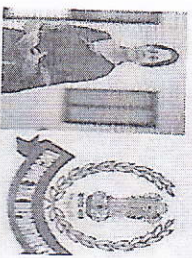

आर्थिक गतिविधियों को पटरी पर लाकर वर्ष 2024-25 तक पांच लाख करोड़ डॉलर की अर्थव्यवस्था बनाने के लक्ष्य को हासिल करने के लिए अगले वित्त वर्ष के बजट में लोगों विशेषकर मध्यम वर्ग को क्वच राशिक को बढ़ाने के उद्देश्य से आयकर में बड़ी राहत मिल सकती है।
वित्त मंत्री निर्मला सीतारमण एक फरवरी को वित्त वर्ष 2020-21 का बजट पेश करेंगी। वर्तमान सूस्त पड़ी अर्थव्यवस्था के मद्देनजर इस बजट को लेकर काफी उम्मीद की जा रही है। विश्लेषक ऐसी उम्मीद कर रहे हैं कि वित्त मंत्री कोरपोरेट कर में



कमी की तर्ज पर आयकर में भी छूट देकर लोगों की क्वच शक्ति को बढ़ा सकती है।
उनका कहना है कि 2.50 लाख रुपये से लेकर पांच लाख रुपये तक के पहले स्लेब पर पांच फीसदी कर बना रह सकता है लेकिन पांच लाख रुपये से दस लाख रुपये तक की आय पर कर दर 20 फीसदी से घटाकर 10 फीसदी किया जा सकता है।
