Sub.: Allotment of 71,11,111 convertible warrants on preferential basis under the provisions of Chapter V of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("ICDR Regulations") and Section 42 of Companies Act, 2013

Dear Sir / Madam,

In continuation to our earlier communication dated February 26, 2019 and pursuant to the approval of shareholders obtained on March 25, 2019, we would like to inform you that the Executive Committee of the Board of Directors of the Company today has issued and allotted 71,11,111 (Seventy One Lakhs Eleven Thousand One Hundred Eleven Only) convertible warrants at a price of Rs.180/- each on a preferential basis to entities as mentioned in **Annexure - 1** ("Investors"), entitling them to subscribe to an equivalent number of equity shares of face value of Re.1/- each at a premium of Rs.179/- per share as per the provisions of Chapter V of ICDR Regulations.

The warrant holders shall be entitled to exercise the warrants to subscribe to equity shares of the Company in compliance with the ICDR Regulations and the agreement between the Company and the Investors.

The Company has received the upfront payment of Rs.32,00,00,000/- (Rupees Thirty Two Crore only) which is equivalent to the 25% of total consideration as per terms of preferential issue. Since the Company has allotted warrants, there is no change in the paid up equity share capital of the Company.
