Further, as disclosed in our red herring prospectus dated July 6, 2021 and prospectus dated July 19, 2021, ZVCL does not have any active business operation.

It may be further noted that ZVCL is not a material subsidiary of the Company, and the dissolution of ZVCL will not affect the turnover/revenue of the Company.
