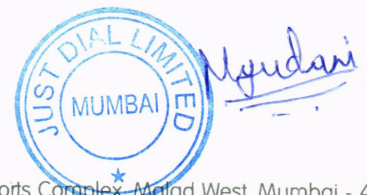


3. **Alteration of Articles of Association of the Company**
