सुरक्षिततेच्या कारणांमुळे शर्मा यांना मुंबईतील ऑर्थर रोड कारागृहातून येरवडा कारागृहात हलवण्यात आले आहे. कारागृहात पोटात दुखू लागल्याने त्यांच्यावर प्राथमिक उपचार करण्यात आले. त्यानंतर त्यांना ससून रुग्णालयात दाखल करण्यात आले होते उपचारानंतर पुन्हा कारागृहात नेल्यावर त्यांची प्रकृती पुन्हा बिघडली. त्यांना पुन्हा रुग्णालयात दाखल करून विविध वैद्यकीय चाचण्या करण्यात आल्या. सध्या त्यांची प्रकृती स्थिर असल्याची माहिती पोलिसांनी दिली.
