Notice is hereby given that the 23rd Annual General Meeting ("AGM") of the Members of SBI Life Insurance Company Limited ('the Company') will be held on Tuesday, August 29, 2023 at 04:00 P.M. The notice of the 23rd AGM and the Annual Report for the FY 2022-23 have been sent, through electronically only to those shareholders whose email addresses are registered with the Depository Participant's/Registrar & Share Transfer Agent/ the Company. The Notice and Annual Report are also available on the Company's website www.sbilife.co.in website of the stock exchanges i.e. www.nseindia.com & www.bseindia.com and also on the website of KFinTech [https://evoting.kfintech.com](http://evoting.kfintech.com)

In accordance with the above circulars, the Company has completed the dispatch of the Notice along with the Annual Report on Friday, August 4, 2023 through electronic mode. The requirement of sending physical copy of 23rd AGM Notice and Annual Report to the members has been dispensed with vide the aforementioned circulars.

Members are requested to get their email addresses and mobile number registered with the concerned depositories or the Company's Registrar & Share Transfer Agent (RTA), KFin Technologies Limited at einward.ris@kfintech.com with copy to the Company at investor@sbilife.co.in to get their email addresses registered. Members are requested to quote their DP ID & Client ID/Folio No. in all correspondence with the RTA and/ the Company.

Pursuant to the requirements under aforementioned Act, Rules, Regulations & the Circulars, the item of business to be transacted at the AGM through electronic means. The Members are provided with facility to cast their votes on all resolutions set forth in the notice of the AGM, through remote e-voting prior to the date of the AGM and e-voting during the AGM for those Members who could not cast their votes earlier through remote e-voting. The Company has engaged KFin Technologies Limited ("KFintech") for facilitating the voting through electronic means, as the authorized agency.

The remote e-voting period will commence at 09:00 A.M. IST on Friday, August 25, 2023 and end at 05:00 P.M. IST on Monday, August 28, 2023. During this period, Members of the Company as on the cut-off date of Tuesday, August 22, 2023 may cast their votes, electronically through remote e-voting as well as e-voting at the AGM. The remote e-voting will not be allowed beyond the aforesaid date and time and the remote e-voting module shall be disabled upon expiry of aforesaid period. A Person who is not a member as on cut-off date should treat the notice for information purpose only. The facility for e-voting shall be made available at the AGM and Members who cast their vote by remote e-voting prior to AGM may also attend the AGM but shall not be entitled to cast their vote again.
