# লব্ধকের গ্রামে কল থচ জল পড়ে না



উচিত বলে আমি মনে করি। নইলে ভুগতে হবে আমাদের সকলকেই। অন্যদিকে খয়রাশোল ব্লকের ১০ টি পঞ্চায়েতের মাত্র একটিতে অর্থাৎ খয়রাশোলে আংশিক জল সরবরাহের ব্যবস্থা করেছে জেলা জনস্বাস্থ্য কারিগরি দফতর। বাকি ৯টি পঞ্চায়েত অবহেলার শিকার। এমনই জোরালো অভিযোগ তুলেছেন তৃণমূল কংগ্রেসের নেতা স্বপন সেন। তিনি বলেন, 'আমরা প্রাকৃতিক নিয়মেই শুধা-রুখা অঞ্চলের বাসিন্দা। তারপর জনস্বাস্থ্য কারিগরি বিভাগের খামখেয়ালিপনার শিকার। আমি বীরভূম জেলার তৃণমূল সভাপতি অনুব্রত মণ্ডলের নজরে এনেছি বিষয়টি। খয়রাশোল ব্লকের খয়রাশোল পঞ্চায়েতে মাত্র ১৫-২০টি কলে জল পড়ে তাও সব দিন নয়। হজরতপুর পঞ্চায়েতের মুন্দিরা, নওপাড়া, হজরতপুর এই কয়েকটি জায়গায় পাইপলাইন হয়েছে মাত্র। কোনো কোনো জায়গায় রাস্তার স্ট্যান্ড কল বসানো হয়েছে। কল থাকলেও ওই কলে জল পড়ে না। খয়রাশোল পঞ্চায়েত সমিতির সভাপতি শ্যামল গায়েরও পানীয় জলের আকালের আশঙ্কার কথা বলেছেন। তিনি জানান, 'খয়রাশোল নলবাহী বিশুদ্ধ পানীয় জল সরবরাহ খানিকটা নড়বড়ে অবস্থায় আছে। সেটিকে আরো শক্ত পোক্ত করে তোলার জন্য আমি জনস্বাস্থ্য ও কারিগরি বিভাগের সঙ্গে কথা বলব। জল কষ্ট সমাধানের জন্য বীরভূম জেলার সভাপতি বিকাশ রায় চৌধুরীর সঙ্গে কথা বলব। কথা বলব বীরভূমের জেলা তৃণমূল সভাপতি

অনুব্রত মণ্ডলের সঙ্গেও। খয়রাশোল ও নাকরাকোন্দা একাংশে নলবাহী জল সরবরাহ হয় অনিয়মিতভাবে। বীরভূম জেলা তৃণমূল সভাপতি অনুব্রত মণ্ডল জানান, 'মানুষের চাহিদা মেটাতে যা যা করার সবটাই করা হবে। প্রতিটি গ্রামে নলবাহী বিশুদ্ধ পানীয় জল পৌঁছে দেওয়ার পরিকল্পনা নিয়েছেন আমাদের মুখ্যমন্ত্রী মমতা বন্দ্যোপাধ্যায়। সেই মতো কাজও শুরু হয়েছে। খয়রাশোল তার থেকে বাদ যাবে না।' জল নিয়ে বিদায়ী সাংসদ শতাব্দী রায়কে খয়রাশোল গ্রামে ভোট প্রচারের সময় ফ্লোভের মুখে পড়তে হয়েছে। পানীয় জল না পেয়ে ক্ষুব্ধ মানুষ। ২০১৬ সালে জনগণের ভোটে জিতে বিধায়ক নরেশচন্দ্র বাউরি খয়রাশোল ব্লকের গ্রামে ১ বছরের মধ্যেই পানীয় জলকষ্ট দূর করার আশ্বাস দিয়েছিলেন। বিধায়ক তহবিল থেকে শুধুমাত্র ৭টি সোলার সাবমারসিবল বসনোর কাজ বছর খানেক আগে শুরু করলেও এখনো তা অসম্পূর্ণ। বিধায়ক নরেশচন্দ্র বাউরি বলেন, 'আরও সোলার সাবমারসিবল বসনোর জন্য বিধায়ক তহবিল থেকে টাকার অনুমোদন দিয়েছি।' জনস্বাস্থ্য ও কারিগরি বিভাগের জেলার ভারপ্রাপ্ত বাস্তবকার বলাইলাল সাহার সঙ্গে কথা বলা হলে তিনি জানান, 'আমি নিজে খয়রাশোল এলাকা পরিদর্শন করে বিহিত ব্যবস্থা করব। কল থাকতেও কেন জল পড়ে না সেটাও দেখা হবে।' বীরভূম জেলার সভাপতি বিকাশ রায় চৌধুরী বলেন, 'পানীয় জলের আকাল দূর করতে যাবতীয় পদক্ষেপ করা হবে।'
