Sub: Incorporation of 2 new Special Purpose Vehicle (SPV's) for development of Independent Transmission Projects (wholly owned subsidiaries of PFC Consulting Limited (PFCCL), a wholly owned subsidiary of Power Finance Corporation Limited(PFC))

Madam/Sir,

This is to inform that the following 2 Special Purpose Vehicle (SPV's) for development of Independent Transmission Projects have been incorporated as wholly owned subsidiaries of PFC Consulting Limited (a wholly owned subsidiary of Power Finance Corporation Limited)

- i) **BIKANER III NEEMRANA TRANSMISSION LIMITED** for development of "Transmission system for evacuation of power from Rajasthan REZ Ph-IV (Part-1: Bikaner Complex) Part-A" on **08**th **June, 2023**
- ii) NEEMRANA II BAREILLY TRANSMISSION LIMITED for development of "Transmission system for evacuation of power from Rajasthan REZ Ph-IV (Part-1: Bikaner Complex) Part-D" on 08th June, 2023.

PFCCL has been nominated as the 'Bid Process Coordinator' (BPC) for selection of developer through tariff based competitive bidding for the Independent Transmission Projects (ITPs) by Ministry of Power, Government of India.

As per the provisions of tariff based competitive bidding Guidelines issued by the Ministry of Power, the BPC has to prepare the project profile and initiate the process of land acquisition and forest clearance, if required. For these activities, a **Special Purpose Vehicle (SPV)** is required to be incorporated which will take up various preparatory activities of the transmission projects e.g. survey and preparation of report, initialization of the process of acquisition of land and also initiate the process of seeking forest clearance, if required.

The SPV has to be transferred to the Successful Bidder selected through International Competitive Bidding Process under Tariff Based Competitive Bidding Guidelines for Transmission Service issued by Ministry of Power.

Ministry of Power (MoP) vide letter dated January 16, 2023 has forwarded the Gazette Notification No. CG-DL-E-14012023-241990 dated January 13, 2023 appointed PFC Consulting Ltd as the BPC for following Transmission Schemes to be developed through Tariff Based Competitive Bidding Process:

- Transmission system for evacuation of power from Rajasthan REZ Ph-IV (Part-1: Bikaner Complex) Part-A
- ii) Transmission system for evacuation of power from Rajasthan REZ Ph-IV (Part-1: Bikaner Complex) Part-D

Accordingly, the above named two SPVs have been incorporated as a wholly owned subsidiary of PFCCL to develop the aforementioned transmission schemes after approval of the Board of Directors of PFCCL and PFC. All these SPVs will be transferred to the successful bidders after the completion of the bidding process. The successful bidders selected through the bidding process would develop the projects.
