EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

The following Statement sets out all material facts relating to the Special Business mentioned in the accompanying Notice:

Item No.: 3

The Board of Directors at its meeting held on June 3, 2021, pursuant to the recommendation by the Audit Committee of the Board, appointed M/s. R.J. Goel & Co., Cost Accountants as Cost Auditors to conduct the audit of the cost records of the Company for the Financial Year 2021-22 at a remuneration of ₹2,50,000/- excluding GST as applicable and reimbursement of travelling and other out-of-pocket expenses actually incurred by the said Auditors in connection with the cost audit.

In accordance with the provisions of Section 148 of the Companies Act, 2013 read with the Companies (Audit and Auditors) Rules, 2014, the remuneration payable to the Cost Auditors is to be ratified by the Members of the Company.

The proposal is accordingly recommended by the Board for approval/ratification by the Members by means of an ordinary resolution.

None of the Directors or Key Managerial Personnel of the Company and/or their relatives (to the extent of their shareholding in the Company, if any) is concerned or interested, financially or otherwise, in the resolution set out at Item No. 4 of the Notice.

Item No.: 4 and 5

The members of the Company at their 32nd Annual General Meeting (AGM) held on September 29, 2017 had appointed Shri Virendra Singh Jain as an Independent Director of the Company for his first term of five consecutive years w.e.f. January 28, 2017.

Pursuant to an amendment made w.e.f. April 1, 2019 a new clause 1A was inserted in Regulation 17 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as per which the Company is required to take approval of the Members by means of a Special Resolution for continuation of Directorship of Shri Virendra Singh Jain, who will be attaining the age of 75 years on July 24, 2021, by giving justification thereof.

Further, as per provisions of the Companies Act, 2013, the Independent Directors shall hold office for a term up to five consecutive years, but shall be eligible for reappointment, subject to compliance with certain conditions and on passing of a Special Resolution by the members of the Company. Further, such Independent Directors will also not be subject to retirement by rotation.

Shri V.S. Jain was a member of Public Enterprises Selection Board (PESB), which has been set up by the Government with the objective of evolving a sound managerial policy for central public sector enterprises and to advise the Government on appointments to top management posts at the Board level. In the past, he has served as the Chairman of Steel Authority of India (SAIL), Managing Director of Jindal Stainless Limited and has held the post of Executive Director of Indian Oil Corporation (IOC). He has also served as an independent director on the Boards of Rashtriya Ispat Nigam Ltd., Essar Oil Ltd., and National Multi-Commodity Exchange of India. He is presently on the Board of Dalmia Bharat Ltd. He is a fellow member of the Institute of Chartered Accountants of India as well as the

Institute of Cost Accountant of India.

Since his joining the board of the Company, the Company has been immensely benefited with his guidance and support. His vast experience in the industry and the expertise gained over the years by being in the top positions of reputed organisations has been useful to the company. His wisdom and knowledge have been contributing factors for the growth of the Company over the years.

Therefore, it was felt desirable in the best interests of the Company to recommend his appoint for another term beyond the age of 75 years to the members.

The Board, accordingly, based also on the recommendation of the Nomination and Remuneration Committee of the Board, decided to recommend to the members his continuation as an Independent Director of the Company beyond the age of 75 years and also the appoint for the 2nd term as Independent Director of the Company.

The Company has received declarations from Shri Virendra Singh Jain to the effect that he meets with the criteria of independence and that he is not aware of any circumstance or situation, which exists or may be reasonably anticipated, that could impair or impact his ability to discharge the duties with an objective independent judgment and without any external influence, as prescribed under the Companies Act, 2013 and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"). At present he is neither disqualified from being appointed as a Director in terms of Section 164 of the Act nor is debarred from holding the office of Director pursuant to any SEBI Order. He is also registered with the database of Independent Directors as constituted by MCA pursuant to the relevant notifications.

In the opinion of the Board, Shri Virendra Singh Jain fulfils the conditions specified in the Companies Act, 2013 and Rules made thereunder and Listing Regulations for reappointment as Independent Director of the Company and he is independent of the Management.

Accordingly, the Board recommends continuation of Shri V.S. Jain as a Non-Executive Independent Director on attaining the age of 75 years on July 24, 2021, till January 27, 2022 and his reappointment as Independent Director of the Company, for the second term w.e.f. January 28, 2022 till September 30, 2024.

Detailed information regarding the appointee is given in the notes appended to the Notice of this Meeting.

The Board recommends these proposals for approval of the members by means of a special resolution as specified in Item Nos. (4) and (5).

Except Shri V.S. Jain, the appointee himself and his relatives, none of the Directors or Key Managerial Personnel of the Company and/or their relatives (to the extent of their shareholding in the Company, if any) is concerned or interested, financially or otherwise, in the aforesaid special resolutions.
