**Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015**

This is in reference and furtherance to the disclosure made on 15<sup>th</sup> February, 2024 under Regulations 30(3), 30(4) read with Para B, Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements), 2015 by Jagran Prakashan Limited ("JPL"/ "Company").

Please note that the matter titled "Mahendra Mohan Gupta & Ors. v. Devendra Mohan Gupta & Ors., C.P. No. 64 of 2023" along with all accompanying applications was listed on 5<sup>th</sup> March, 2024 before the Hon'ble NCLT, Allahabad. It was listed on 4<sup>th</sup> March, 2024 but since the Hon'ble Bench was not sitting on such date it was re-notified for 5<sup>th</sup> March, 2024.

On 5<sup>th</sup> March, 2024, the matter was taken up by the Hon'ble Bench at 02:00 PM and counsels for the Petitioners (Mr. Mahendra Mohan Gupta, Mr. Shailesh Gupta, VRSM Enterprises LLP) sought issuance of notice on an application filed by them seeking amendment to the company petition to ensure that the prayers sought in the various applications filed by them are treated as part and parcel of the main company petition. The counsels for the Respondents had no objection to the amendment for inclusion of the said prayers, and accordingly the said application was allowed by the Hon'ble Bench.

An Intervention Application (IVN. P. No. 1 of 2024) filed on behalf of an intervener was sought to be withdrawn and the same was allowed by the Hon'ble Bench.

Thereafter, counsel for the Petitioners commenced final arguments on the main company petition and such arguments continued around 04:00 PM.

The Hon'ble Bench was pleased to list the matter for further arguments on 18<sup>th</sup> March, 2024 at 02:30 PM on which date the Petitioners will continue with their arguments.



## **ORDER**

### **CA No.04/2024**

1. Ld. Sr. Counsels with their assisting counsels are present for their respective parties.
