Subject: Disclosure U/R 30(3) of SEBI (LODR) Regulations-2015 read with Schedule III (Part A) in connection with temporary disruption/ closure of the manufacturing activities/ operations of the company due to directives of lockdown viz. ("FORCE MAJEURE") promulgated by the Government of India and State Government Authorities with a view to contain the spread of COVID-19 virus declared as 'PANDEMIC' by WHO:

Dear Sir/Madam,

We would like to inform you that in the wake of the global COVID-19 pandemic, and in compliance with the directives of Government of India/State Governments, **Parmeshwari Silk Mills Limited** ("the Company") has adopted several measures to ensure the safety and wellbeing of all its employees & workers. Across our office and site locations, the Company has implemented heightened hygiene, health and sanitation measures and is promoting social distancing.

In view of the 21-day nationwide lockdown announced by the Government of India (GOI) with effect from March 25, 2020 to April 14, 2020 ("Phase 1"), 19-day nationwide lockdown from April 15, 2020 to May 03, 2020 ("Phase 2"), 14-day nationwide lockdown from May 04, 2020 to May 17, 2020 ("Phase 3") and now 14-day nationwide lockdown from May 18, 2020 to May 31, 2020 ("Phase 4") besides the "Janta Curfew" on March 22, 2020 and subsequent curfew imposed by Government of Punjab, to control the spread of COVID-19, the Company's operations related to manufacturing, supply chain, warehouses, and offices are disrupted. The impact of COVID-19 on the Company's operations cannot be fully ascertained at this point.

Based on the guidelines issued by the GOI, various ministries/ departments of State Government, the Company commenced its production at around 20% of its normal production capacity from May 20, 2020 and currently operating at 25% capacity Utilization.

We would like to further inform you that the safety and well-being of our employees, customers, vendors, business partners and the communities in which we live and work is of paramount importance to us. The Company will continue to closely monitor the rapidly changing situation while ensuring adherence to government guidelines and advisories as well as the Company's internal control and corporate governance standards.
