No stay on mobile internet ban during exams: Gauhati HC

GUWAHATI: The Gauhati High Court on Friday refused to stay the Assam government's decision to suspend mobile internet services during examinations for various government posts.

The move was necessitated to ensure free and fair examination, given the history of question papers being leaked through WhatsApp or social media, Salkia said.

"The intention of the government is to bring back the confidence of the people in the recruitment process. We had less than 10 per cent absentees in last Sunday's exam, which was as high as up to 50 per cent earlier," he maintained.

Over 14.30 lakh candidates in total are expected to appear for the recruitment to 30,000 Grade III and IV posts. The Grade IV examinations took place on Sunday in two shifts, and the posts for the Grade III posts will be held on August 28.

NGT halts sand mining on Brahmani river bed

THE National Green Tribunal (NGT) on Friday ordered a halt to sand mining operations on Brahmani river bed in Bargarh district until a study report of annual replenishment rate of sand is available with the Jajpur Collector.

The Bench issued the directions until a study report of a petition after taking note of the inspection report submitted by a committee constituted by it to ascertain the veracity of the allegations.

TMC protests release of convicts in Bilkis Bano case

KOLKATA: Members of the TMC women's wing bit the streets across West Bengal on Friday, protesting against the release of 11 convicts in the 2002 case of Bilkis Bano's gangrape and murder of her family members.

State to implement ARUA to replenish groundwater table

THE Odisha government will soon launch a scheme called 'artificial recharge to underground aquifer' (ARUA) to replenish the depleting groundwater table in the State.

The scheme will be implemented from the budget of the Water Resources Department in six semi-critical and 26 approaching semi-critical blocks having ground water extraction of more than 66 per cent of the entire State at an estimated cost of ₹49.23 crore over a period of five years from 2022-23 to 2026-27.

Action against Collector demanded

Balagar: Based on a petition filed by a Kantabari-based human rights activist Ashish Khaitan against the district administration on the deteriorating health care in the district, the National Human Rights Commission (NHRC) has sought an action taken report from the Collector within four weeks.

Police cautions electricity consumers against cyber fraud

BHUBANESWAR: ODISHA POLICE on Friday cautioned citizens against cyber criminals who send fake messages by SMS and WhatsApp asking electricity consumers to pay their bills else their connection will be disconnected.

Cyber experts have advised electricity consumers to verify the sources of SMS. Most do not pay bills from untrustworthy sources, not to install any apps that allows an unsuspecting user to share his/her screen with others, not to make payments to private accounts, not to click on the link provided in the message or contact the mobile phone number shared by the scammers.
