Sub: Consolidated Scrutinizer's Report for remote e-voting conducted pursuant to the provisions of section 108 of the companies Act 2013 read with Rule 20 of the Companies (Management and Administration) Rule 2014 as amended by Companies (Management and Administration) Amended Rules 2015 for the 67th (Sixty Seventh) Annual General Meeting ('AGM') of the Members of The Yamuna Syndicate Limited ('the Company') will be held on Monday, September 20, 2021, at 11:00 a.m. (IST) through Video Conferencing ('VC') or Other Audio Visual Means ('OAVM') for which purpose the Registered Office of the Company situated at Radaur Road, Yamunanagar-135001.

- I, Pramod Kothari, Practicing Company Secretary and proprietor of Pramod Kothari & Co., was appointed as Scrutinizer of the company by the board Directors of the company pursuant to section 108 of the companies Act 2013 read with Rule 20 of the Companies (Management and Administration) Rule 2014 as amended by Companies (Management and Administration) Amended Rules 2015, to conduct the remote e-voting and e- voting process during the AGM in respect of the below mentioned resolutions at the AGM of the members of the company on Monday, September 20, 2021 at 11:00 A.M, through Video Conferencing (VC) / Other Audio Visual Means OAVM).
- 2. The notice dated August 23, 2021, as confirmed by the Company was sent to the shareholders in respect of the below mentioned resolutions passed at the AGM of the Company through electronic mode to those Members whose email addresses are available with the Company/ Depositories, in compliance with the MCA Circular dated April 8, 2020 April 13, 2020, May 5, 2020 and January 13, 2021 ("MCA Circulars") and SEBI Circular dated May 12, 2020 and January 15, 2021.

The MCA Circulars inter-alia provide for relaxation in the manner in which the AGM will be held including the manner of sending the Notices and Annual Reports to the shareholders and the manner of voting at the meeting, which was necessitated on account of the outbreak of COVID -19 pandemic. Further, pursuant to these Circulars, physical attendance of members had been dispensed with and accordingly the facility for appointment of proxies by the

members was dispensed with. Members who attended the meeting through VC or OAVM were counted for reckoning the quorum under section 103 of the Companies Act, 2013.

- 3. The Company had availed the e-voting facility offered by National Securities Depository Limited ("NSDL") for conduction remote e-voting by the shareholders of the company.
- 4. The shareholders of the company holding shares as on the cut- off date of Monday, September 13, 2021 were entitled to vote on the proposed resolutions as set out in Items Nos. 01 to 3 in the Notice of the AGM of the members of the Company.
- 5. The facility provided for the remote e-voting period commences on Friday, September 17, 2021 at 9.00 A.M. and ends on Sunday, September 19, 2021 at 05.00 P.M., the NSDL E-voting facility was blocked thereafter. The Company had also provided e-voting facility to the shareholders present at the AGM through VC / OAVM and who had not cast their vote earlier.
- The votes cast were unblocked on Monday, September 20, 2021 after the conclusion of the AGM and was witnessed by two witnesses, who were not in the employment of the Company and were counted.
- 7. I, have scrutinized and reviewed the remote e- voting prior and during the AGM and the vote cast therein based on the data downloaded from the NSDL e-voting system.
- 8. The Management of the company is responsible to ensure compliance with the requirements of the Act and rules relating to remote e voting prior and during the AGM on the resolutions contained in the notice of AGM.
