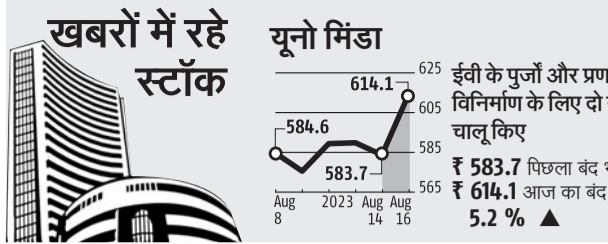

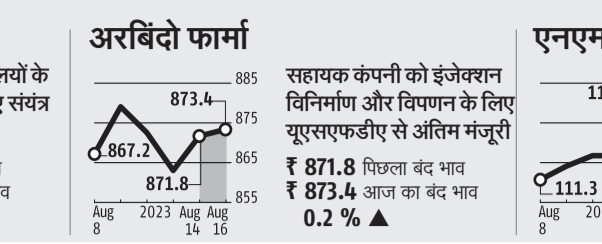

अदाणी परिवार ने बुधवार को अदाणी पावर की 8.1 फीसदी हिस्सेदारी कई ब्लॉक डील के जरिये जीक्यूजी पार्टनर्स को 1.1 अरब डॉलर यानी 9,000 करोड़ रुपये में बेच दी। बुधवार के निवेश के साथ ऑस्ट्रेलिया में सूचीबद्ध निवेश फर्म जीक्यूजी पार्टनर्स की अदाणी समूह की कंपनियों में कुल निवेश इस साल मार्च के बाद से अब तक 34,000 करोड़ रुपये पर पहुंच गया। अदाणी समूह के शेयरों पर हिंडनबर्ग रिसर्च की रिपोर्ट के बाद भी चोट पड़ी थी।

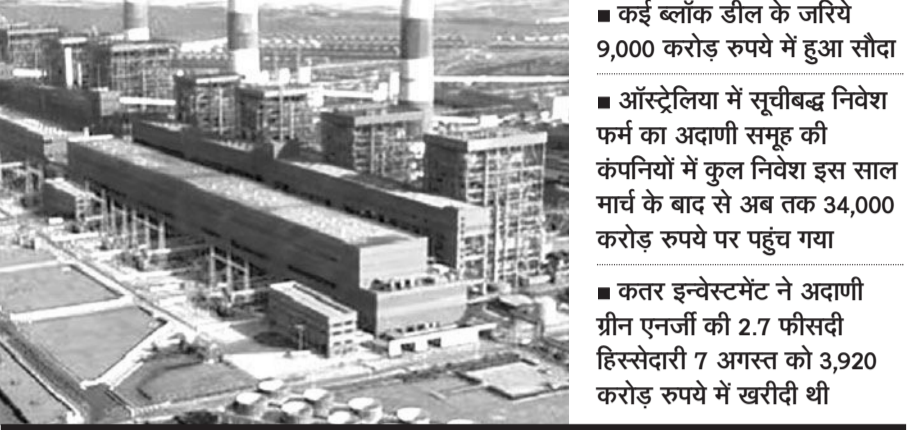

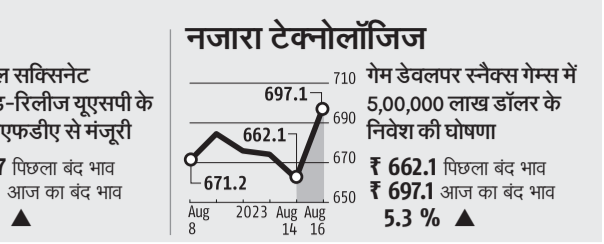

हुंडै मोटर इंडिया (एचएमआईएल) ने जनरल मोटर्स इंडिया (जीएमआई) के साथ महाराष्ट्र के तलेगांव में उसके संयंत्र की भूमि, भवन, कुछ मशीनरी और विनिर्माण उपकरण का अधिग्रहण करने के लिए आज खरीद समझौता किया। वह यहाँ वर्ष 2025 तक उत्पादन शुरू करने की योजना बना रही है। दक्षिण कोरिया की इस कार विनिर्माता ने यह खुलासा नहीं किया है कि वह संयंत्र खरीदने के लिए अमेरिकी फर्म को कितनी राशि का भुगतान करेगी। संयंत्र की वार्षिक उत्पादन क्षमता 1,30,000 वाहन है।

एचएमआईएल ने एक बयान में कहा कि चूंकि कंपनी इस वर्ष की पहली छमाही में अपनी उत्पादन क्षमता (तमिलनाडु में श्रीपेरंबुदूर संयंत्र में) 7,50,000 वाहनों से बढ़ाकर 8,20,000 वाहनों तक कर चुकी है, इसलिए जीएमआई संयंत्र की यह क्षमता वृद्धि एचएमआईएल के लिए लगभग 10 लाख उत्पादन की नींव रखेगा।
