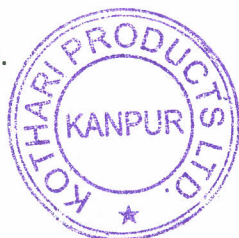

The proposed scheme of Amalgamation of Adyashakti Realtors Ltd. with the company had been approved by the requisite majority of its members and creditors and the same is pending for approval by the Regional Director (Northern Region), Ministry of Corporate Affairs. The impact of the aforesaid amalgamation has not been considered in the aforesaid results which will be considered once the scheme is given effect to. The appointed date for the said amalgamation is 1st April, 2019.
