In terms of the Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that an impromptu meeting of the Directors of the Company held through "Other Audio Visual Means" today instant to, *inter-alia*, review the operations of the Company and to consider certain important functional / operational decisions.

In this connection, we would like to inform you that the Company is currently encountering difficulties in sourcing a specialized grade Bauxite in Gujarat which is an important raw material in its production of Brown Fused Alumina (BFA) and other products at its Porbandar Plant situated at GIDC Industrial Area, Porbandar- 360577, Gujarat. However, the Management of the Company is actively working towards finding a sustainable supply of the raw material.

Presently, as a result of this raw material shortage, a significant part of the Company's Porbandar operations are suspended, which may temporarily lead to an adverse impact on the Company's performance.

However, we would like to submit that other value-added high quality ceramic products and hydrocarbon-solutions of the Company, which are not dependent on the Porbandar Plant, continue to do well.

The Company shall keep you updated in the matter.
