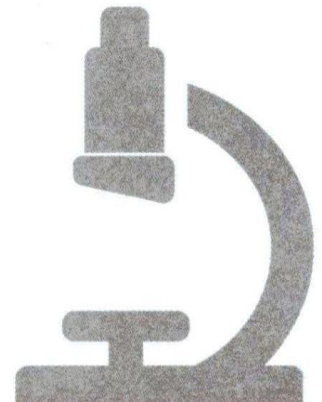
With the permission of the Members, the chairman declared that the Notice convening the meeting, having been circulated to the members to be taken as read.
