Will sanction Chinese officials for rights abuse in Tibet: Biden

Washington: Slamming China's plan to further tighten control over Tibet, Democratic presidential candidate Joe Biden has said that if voted to power, his administration will sanction Chinese officials responsible for human rights abuses in the remote Himalayan region. Noting that the Chinese Government recently announced plans to further tighten control over Tibet, thereby continuing to erode the human rights, religious freedoms, and dignity of the Tibetan people, the former US vice president said that these are only the latest efforts by Beijing to crush ethnic minorities that seek to preserve their distinct culture, language and beliefs. "My administration will sanction Chinese officials responsible for human rights abuses in Tibet, and step up support for the Tibetan people, including by expanding Tibetan language services at Radio Free Asia and Voice of America to get information from the outside world into Tibet," Biden said. Biden vowed that as president he will meet with the Dalai Lama, appoint a new Special Coordinator for Tibetan

Issues, and insist that the Chinese government restore access to Tibet for US citizens, including American diplomats and journalists. "Where (President Donald) Trump has turned a blind eye, a Biden-Harris administration will stand up for the people of Tibet," Biden said. In his statement, Biden alleged that Trump has been weak on his China policy. "Once again, the silence from President Trump has been deafening, as he focuses instead on his empty trade deal with Beijing and protecting his 'very good friendship' with Chinese President Xi Jinping. It's disgraceful, though not surprising, that Trump is the first American president in three decades who has not met or spoken with His Holiness the Dalai Lama," he said. "Trump hasn't even fulfilled the statutory requirement to appoint a Special Coordinator to lead America's efforts on this vital issue. It's no wonder China's leaders believe they have a free hand to deepen repression in Tibet, just as they have in Hong Kong and Xinjiang," Biden said. **PTI**

Stop meddling in Hong Kong affairs, China tells UN experts

Beijing: China issued a fierce rebuke Friday to UN experts who said a draconian national security law imposed upon Hong Kong poses a serious risk to the city's freedoms and breaches international legal obligations. Beijing has faced a barrage of criticism over the legislation, imposed late June after pro-democracy protests rocked the semi-autonomous city last year. The law, which criminalises secession, subversion, terrorism and colluding with foreign forces, carries a maximum life sentence and has intimidated many protesters into silence. In a letter made public Friday, the UN special rapporteurs on human rights warned

parts of the legislation "appear to criminalise freedom of expression or any form of criticism" of China. In customarily strong language, China's foreign ministry was swift to strike down the allegations, saying the law "punishes an extremely small number and protects the absolute majority" in the financial hub. "Some people disregard the facts and maliciously slander China's human rights situation... and crudely interfere in China's internal affairs," ministry spokeswoman Hua Chunying told reporters. "Stop meddling in Hong Kong affairs and China's affairs in any way." Hong Kong lurched into

chaos last year as pro-democracy protesters — furious at perceived encroachment by China on the city's freedoms — clashed with police. Unrest has simmered down thanks to coronavirus restrictions and the chilling effect of the security law — under which more than 20 people have been arrested, including a prominent media tycoon. The letter by the UN advisers — the first issued since the law blanketed the southern Chinese city — gave a vigorous dissection of the damage being inflicted upon the freedoms once enjoyed in Hong Kong, enshrined in an agreement made before the 1997 handover from British colonial rule back to China. **AFP**

US poll chiefs worry about uncertainty as US voting nears

 Political battles and pending court fights threaten to upend months of planning for the pandemic election, election officials are warning. In key states, they remain hamstrung with only weeks to prepare. Ongoing partisan litigation could dictate dramatic last-minute changes to rules and procedures in several states. Legislatures continue debating laws that could change how votes are processed. Meanwhile, money to pay for counting 150 million or more votes during the pandemic is stalled in Congress. Time is short. Though Election Day is two months away, ballots are being mailed to voters on Friday in North Carolina. By the end of the month early voting will be underway in states like Minnesota, Virginia and Vermont. Many election officials in states likely to decide the presidential race — the frontline planners — say they believe they will be ready.

Judge bars Kanye West from appearing on Arizona's ballot

 A judge has barred Kanye West from appearing on the November 3 ballot in Arizona, concluding that a voter who challenged his candidacy had shown he would probably prevail and had established the possibility of an irreparable harm if the rapper's name were to appear on the ballot. The ruling Thursday by Judge Scott McCoy said that the voter who challenged West's bid in Arizona "established that the relative hardships favour him." Putting West on the ballot would create confusion for voters, his lawyers argued.

Russia's Covid vaccine safe, passes early trial test: Lancet

London: Patients involved in early tests of a Russian coronavirus vaccine developed antibodies with "no serious adverse events", according to research published in The Lancet Friday, but experts said the trials were too small to prove safety and effectiveness. Russia announced last month that its vaccine, named "Sputnik V" after the Soviet-era satellite that was the first launched into space in 1957, had already received approval. This raised concerns among Western scientists over a lack of safety data, with

some warning that moving too quickly on a vaccine could be dangerous. Russia denounced criticism as an attempt to undermine Moscow's research. In the Lancet study, Russian researchers reported on two small trials, each involving 38 healthy adults aged between 18 and 60, who were given a two-part immunisation. Each participant was given a dose of the first part of the vaccine and then given a booster with the second part 21 days later. **AFP**

New Zealand records first virus death in over three months

Wellington: New Zealand recorded its first coronavirus death in more than three months on Friday when a man in his 50s died due to the virus. Health officials said the man was part of a second-wave cluster of infections that emerged in Auckland last month, ending a spell of 102 days free of community transmission in the South Pacific nation. The death at Auckland's Middlemore Hospital on Friday afternoon takes New Zealand's death count from the virus to 23, with the most recent previous fatality on May 24. **AFP**

NATO: Turkey, Greece start talks to reduce risk of conflict

AP ■ ATHENS
 Despite a denial from Greece, the chief of NATO said Friday that Greece and Turkey have started technical discussions aimed at reducing the risk of conflict or accidents amid military tensions between the allies over offshore energy resources in the eastern Mediterranean. No agreement has been reached from the military-level talks, NATO Secretary General Jens Stoltenberg said. Greece's foreign minister, meanwhile, headed to New York to discuss the regional disputes centered around maritime boundaries and drilling rights.

Charlie Hebdo's republication of Prophet cartoon a provocation: Iran

Tehran: Iran has condemned as a "provocation" Charlie Hebdo's republication of cartoons of the Prophet Mohammed to mark the opening of the trial into a 2015 attack on its offices by Islamist extremists. In a statement issued late Thursday, the Foreign Ministry said the reissue of the cartoons was an "insult" to more than one billion Muslims around the world. "The offensive act by the French publication... is a provocation," the Ministry said. "Any insult or disrespect towards Islam's holy prophet... or the other prophets of God (the Jewish and Christian figures also recognised by Muslims)... is absolutely unacceptable," it added. **AFP**

Around the Globe

Beirut: Rescuers resumed a search Friday for possible survivors under rubble in Beirut, buoyed by faint hopes of a miracle a month after a monster blast ripped through the city's port.
Dubai: Bahrain will allow "all flights coming to and departing from the United Arab Emirates" to cross through the island kingdom's airspace — a statement apparently allowing Israeli flights after neighbouring Saudi Arabia issued a similar announcement.
Beijing: An American newspaper says one of its journalists was detained and then expelled from China's Inner Mongolia region while covering tensions over a new policy that reduces the use of the Mongolian language in education.
Lahore: Pakistan Muslim League-Nawaz Vice President Maryam Nawaz and 300 workers of her party were booked on Friday under terrorism charges for allegedly attacking law enforcers and hooliganism.
Hong Kong: Seven human rights experts affiliated with the UN raised concerns over Hong Kong's national security law in a letter addressed to Chinese authorities, saying that the law infringed on certain fundamental rights. In a letter released on Friday, the experts said that the national security law raised a "serious risk" that fundamental freedoms, such as the freedom of expression and peaceful assembly, may be infringed upon.
Brussels: NATO Secretary-General Jens Stoltenberg on Friday condemned the "appalling assassination attempt" on Russian opposition politician Alexei Navalny and called on Moscow to answer questions about the poisoning to international investigators. Navalny fell ill on a flight to Moscow on Aug 20 and was taken to a hospital in the Siberian city of Omsk.

जब दो रन से विश्व रिकार्ड से चूक गए थे गावस्कर

भाषा। नई दिल्ली

वह चार सितंबर 1979 का दिन था जब केनिंगटन ओवल पर सुनील गावस्कर ने अपनी बेमिसाल बल्लेबाजी से इंग्लैंड को पेशानी पर बल ला दिए थे लेकिन तब वह केवल दो रन से चौथी पारी में सर्वोच्च स्कोर का विश्व रिकार्ड बनाने से चूक गए थे और भारत को भी जीत की दहलोज पर पहुंचकर ड्रा से संतोष करना पड़ा था। पहला टेस्ट गंवांने और अगले दो टेस्ट मैच ड्रा कराने के बाद ओवल में चौथे टेस्ट मैच में भारत के सामने 438 रन का मुश्किल लक्ष्य था। उस समय किसी ने भी विश्वास नहीं किया था कि पांचवें दिन जब मैच ड्रा समाप्त होगा तो भारतीय टीम लक्ष्य से केवल नौ रन दूर होगी। यह संभव हो पाया गावस्कर की 221 रन की पारी से जो उस समय मैच की चौथी पारी में दूसरा सर्वोच्च स्कोर था। यह दिग्गज भारतीय सलामी बल्लेबाज उस समय केवल दो रन से वेस्टइंडीज के जार्ज हेडली के रिकार्ड की बराबरी करने से चूक गया था जिन्होंने 1930 में इंग्लैंड के खिलाफ क्रिस्टमटन में 223 रन बनाए थे। यह रिकार्ड आज भी हेडली के नाम पर है। न्यूजीलैंड के नाथन एस्टल ने 2002 में ब्राइस्ट्रच में इंग्लैंड के खिलाफ गावस्कर की रन संख्या को पार करने के बाद 222 रन पर आउट हो गए थे। गावस्कर अपनी इस पारी के दौरान आठ घंटे 10 मिनट तक क्रीज पर रहे और उन्होंने 443 गेंदों का सामना करके 21 चौके लगाए। भारत ने तीन जीत अक्सरों पर चौथी पारी में 400 या इससे अधिक रन बनाए, उनमें से दो मौकों पर गावस्कर ने शतक लगाया और पूर्व कप्तान ब्रिशन सिंह बेदी ने ओवल की पारी के बहाते उनके इस प्रदर्शन को याद किया। बेदी ने ट्विटर पर लिखा, पूरी विनम्रता के साथ भारत एकमात्र ऐसा देश है जिसने चौथी पारी में तीन अक्सरों पर 400 से अधिक रन बनाए जिसमें से एक मैच ड्रा रहा, एक में उसे हार मिली और एक में जीत। यह जरूरी नहीं कि यह क्रम में हो। और ऑरिजनल लिखित मास्टर (गावस्कर) ने तीनों में अहम भूमिका निभाई थी। गौरवलेब है कि भारत ने 1976 में वेस्टइंडीज के खिलाफ पोर्ट ऑफ स्पेन में जब 403 रन के रिकार्ड लक्ष्य को हासिल किया था तब गावस्कर ने 102 रन की पारी खेली थी लेकिन 1978 में आस्ट्रेलिया के खिलाफ एडिलेड में 493 रन के लक्ष्य के सामने भारत के 445 रन में यह सलामी बल्लेबाज 29 रन का योगदान ही दे पाया था।
