APPROVAL OF RECLASSIFICATION OF MS. ABHA JAIPURIA FROM PROMOTER TO PUBLIC CATEGORY

RESOLVED FURTHER THAT for the purpose of giving effect to this resolution, the Board of Directors/Committee(s) of the Board (including the officers authorized by the Board in this regard) and the Company Secretary of the Company be and are hereby authorized severally to do all such acts, deeds, matters and things as it may in its absolute discretion consider necessary, desirable or expedient including application to Stock Exchanges and/ or such other authorities as may be necessary for the purpose, to resolve and settle any questions and difficulties that may arise in the proposed reclassification, signing of all deeds and documents as may be required without being required to seek any further consent or approval of the Board"
