4 संक्रमित, तीन की मौत

बेरोजगार युवाओं को सरकारी खर्च पर प्रशिक्षण देगी सरकार: दुष्यंत

चंडीगढ़, 25 अगस्त (जनसत्ता)।

हरियाणा देश का ऐसा पहला राज्य बन गया है जहां एक साथ प्रदेश के 50 हजार प्रतिभावान युवाओं को सरकारी नौकरियों में परीक्षाओं की तैयारी करवाने के लिए मंच उपलब्ध करवा रहा है। रेलवे, बैंक, कर्मचारी चयन आयोग, डिफेंस आदि में ग्रुप-सी, ग्रुप-डी के अलावा ग्रुप-ए व ग्रुप-बी और हागोटक जैसी उच्च स्तर की तकनीकी परीक्षा की तैयारी करवाने की योजना है।

प्रदेश के युवाओं के इस सपने को साकार करने के लिए मंगलवार को चंडीगढ़ में हरियाणा के उपमुख्यमंत्री दुष्यंत चौटाला की उपस्थिति में हरियाणा के रोजगार विभाग, एम-श्री-एम फाउंडेशन तथा ग्रेडअप के मध्य एक समझौता ज्ञापन (एमओयू) पर हस्ताक्षर किए गए। बाद में पत्रकारों से बातचीत में दुष्यंत चौटाला ने यह एमओयू प्रदेश के प्रतिभावान युवाओं को सरकारी नौकरी की तैयारी करवाने में मील का पत्थर साबित होगा। इसके तहत प्रथम चरण में 50,000 मेधावी अभ्यर्थियों को ऑनलाइन कार्यक्रम के माध्यम से ग्रुप-सी व ग्रुप-डी की नौकरियों के लिए कोचिंग दी जाएगी जिनमें 70 प्रतिशत ग्रामीण व 30 प्रतिशत शहरी युवाओं को शामिल करने का लक्ष्य रखा गया है।

पंचकूला में तीन की मौत, 50 नए कोरोनाग्रस्त

पंचकूला: जिले में मंगलवार को 50 कोरोना संक्रमितों की पुष्टि हुई है। इनमें चंडीगढ़ के 2, मनीमाजरा के 3, मोहाली व यमुनानगर के 1-1 मामले सहित 7 बाहर के मामले शामिल हैं। इसके अलावा तीन की मौत हुई है। तीनों मृतकों में से दो पंचकूला के और एक पंजाब का रहने वाला है। जिला उपायुक्त मुकेश कुमार आहूजा ने बताया कि पंचकूला शहर के 20 मामले आए हैं इनमें गांव कोट में 8, सैक्टर 10 में 3 तथा सैक्टर 12 में 2 मामले

आए हैं। इसके अलावा मोरनी, बरवाला, रायपुररानी, सैक्टर 11, 12 ए, 15, व 20, में भी एक-एक मामला पोजिटिव आया है। उन्होंने बताया कि अब तक 1136 रोगी ठीक हो चुके हैं तथा जिला में 508 पोजिटिव मामले रह गए हैं जिनका स्वास्थ्य विभाग द्वारा इलाज किया जा रहा है। अब तक जिला में कुल 2100 मामले आए हैं जिनमें से 417 मामले बाहरी राज्यों से जिलों से संबंधित हैं। इस प्रकार जिला में 1657 पोजिटिव मामले आए हैं।

मोहाली में 132 मरीज

मंगलवार को मोहाली में 132 और लोग कोरोना की चपेट में आ गए। जबकि सात लोगों ने कोरोना के कारण अपनी जान गंवाई है। वहीं, उपचार के बाद 83 मरीजों को आज अस्पताल से छुटी दे दी गई है। गौर रहे कि नए संक्रमितों के साथ मरीजों का कुल आंकड़ा 2951 पर पहुंच गया है।

वहीं आज शहर के विभिन्न कोरोना अस्पतालों से 67 संक्रमित मरीजों को स्वस्थ होने के बाद छुटी दे दी गई है। अब तक शहर में 1713 मरीजों ने कोरोना को मात देकर घर वापसी की है। अब तक शहर में कुल 40 लोगों की कोरोना के चलते मौत हो चुकी है। वहीं अभी शहर के विभिन्न कोरोना अस्पतालों में 454 संक्रमित मरीज उपचारधीन हैं।
