#### Body of 4-yr-old girl found stuffed in bag in Gurugram

**GURUGRAM:** The body of a four-year-old girl was found stuffed in a bag near the Kisan Bhawan in the Khandsa Anaz Mandi area here, the police said on Friday. The identity of the deceased is yet to be ascertained, the police said. A passerby spotted the body and informed the cops on Thursday morning. "On getting the information, we rushed to the spot with our forensic team and dog squad and found a minor's body stuffed in a bag. The body was decomposing and appeared to be a day or two old," said a police officer.

#### DMK pushing for beggar rehabilitation centres in TN

CHENNAI: The DMK government in Tamil Nadu under Chief Minister MK Stalin is in the process of rehabilitating the beggars in the state. The Supreme Court had stated in a recent verdict that begging cannot be banned through legislation, adding that the court cannot take an "elitist" view in the matter. Taking a cue from the Supreme Court observation, the Tamil Nadu government is planning to open rehabilitation centres across districts.

#### Kerala milk producers get highest price per litre: Minister

THIRUVANANTHAPURAM: Dairy farmers in Kerala get Rs 36 for a litre milk, which is the best procurement price in the country, state Animal Husbandry, Dairy Development, and Milk Cooperatives Minister J Chinchurani said on Friday. In his address at the launch function of Kerala State Cooperative Milk Marketing Federation's (Milma) homogenised toned milk sachet (525 ml/Rs 25), she said that the state-owned Milma has been instrumental in achieving the goal of selfsufficiency in milk production in Kerala.

#### **Covid cases increasing** in TN: Health minister

**TAMIL NADU:** Tamil Nadu Health Minister Ma Subramanian has said that Covid-19 cases in the state have been increasing for the last 3 days. "No of Covid cases has been increasing in the last 3 days. RT-PCR tests have increased. The state recorded 1,859 fresh cases compared to 1,756 cases. Unfortunately, many people are not wearing face masks. Vigilance in TN-Kerala border is increased", said the minister. Kerala has witnessed a rise in Covid cases as well. It recorded 22,064 new cases on Thursday, with a positivity rate of 13.53 per cent.

# Assam cops summon Mizoram MP, paste notice at Delhi home

New Delhi

The Assam Police has summoned Mizoram's lone Rajya Sabha MP K Vanlalvena on August 1 for questioning over his alleged "threatening statement" in connection with the Monday violence along the interstate border, and pasted a notice at his Delhi residence. The Assam Police also said it will take "lawful action" against Vanlalvena who had allegedly made a "threatening" statement over the border clash in which five policemen and a civilian were killed.

Official sources said a team of Assam Police CID, which has arrived in Delhi, visited Vanlalvena's residence and the Mizoram House looking for him without any success.



Sources said Vanlalvena is believed to be avoiding the team. The MP was not available for comments.

Since the Resident Commissioner of Mizoram reportedly refused to receive any notice served on Vanlalvena to join the Assam Police investigation, the CID team pasted the notice on his residence.

### **HC** to hear in Aug pleas of FB, WhatsApp

The request was not opposed by senior advocates Harish Salve and Mukul Rohatgi, appearing for WhatsApp and Facebook respectively.



## 2020 Lockdown: Indian women worst sufferers

in diverse foods even before

The 2020 nationwide lockdown India imposed in response to the Covid-19 pandemic caused disruptions that negatively impacted women's nutrition, according to a new study from the Tata-Cornell Institute for Agriculture and Nutrition.

Published in the journal Economia Politica, the study shows that women's dietary diversity - the number of food groups consumed - declined during the lockdown compared to the same period in 2019. Most concerningly, the drop was due to decreased consumption of foods like meats, eggs, vegetables and fruits, which are rich in micronutrients that are crucial to good health and development.

"Women's diets were lacking

the pandemic, but COVID-19 has further exacerbated the situation," said Soumya Gupta, a research economist at TCI who coauthored the study along with Prabhu Pingali, TCI director; Mathew Abraham, assistant director; and consultant Payal Seth. "Any policies addressing the impact of the pandemic on nutritional outcomes must do so through a gendered lens that reflects the specific, and often persistent, vulnerabilities faced by women."

The Indian government instituted a national lockdown to slow down the spread of Covid-19 on March 24, 2020. Disruptions to agricultural supply chains subsequently led to price fluctuations, especially for nonstaple foods. The lockdown was lifted on May 30, 2020, though some restrictions remained in certain areas of the country.

TCI analyzed surveys of food expenditures, dietary diversity and other nutrition indicators at the national, state and district levels in the states of Uttar Pradesh, Bihar and Odisha. They found that food expenditures significantly declined during the lockdown, especially in less developed districts. Nearly 90% of survey respondents reported having less food, while 95% said they consumed fewer types of food. The largest drop in food expenditures was for micronutrient-rich fresh and dried fruits, as well as animal products such as meat, fish and eggs.

The Kisan Sansad, being held at Jantar Mantar by the Samyukt Kisan Morcha (SKM) despite flooding by heavy rain, passed a resolution, after 2 days of deliberations on July 28-29, urging the Indian Parliament to repeal the Farmers Agreement on Price Assurance and Farm Services Act, 2020, described shortly as the Contract Farming Act. Rejecting the law, it questioned the government's policy to excluding the landless farmers in its agridigitisation plans and linking entitlements to only the landed farmers, which is "clearly against the National Policy for Farmers, 2017." ## 2020 lockdown: Women worst sufferers

**OUR BUREAU / New Delhi** 

The 2020 nationwide lockdown India imposed in response to the Covid-19 pandemic caused disruptions that negatively impacted women's nutrition, according to a new study from the Tata-Cornell Institute for Agriculture and Nutrition.

Published in the journal Economia Politica, the study shows that women's dietary diversity - the number of food groups consumed - declined during the lockdown compared to the same period in 2019. Most concerningly, the drop

was due to decreased consumption of foods like meats, eggs. vegetables and fruits, which are rich in micronutrients that are crucial to good health and development. "Women's diets were lacking

in diverse foods even before the pandemic, but COVID-19 has further exacerbated the situation," said Soumya Gupta, a research economist at TCI who coauthored the study along with Prabhu Pingali, TCI director; Mathew Abraham, assistant director; and consultant Payal Seth. "Any policies addressing the impact of the pandemic on nutritional outcomes must do so through a gendered lens that reflects the specific, and often persistent, vulnerabilities faced by women."

The Indian government instituted a national lockdown to slow down the spread of Covid-19 on March 24, 2020. Disruptions to agricultural supply chains subsequently led to price fluctuations, especially for nonstaple foods. The lockdown was lifted on May 30, 2020, though some restrictions remained in certain areas of the country.

The Group's substantial generation and transmission capacities are tied up under medium to long term power purchase / job work / transmission agreements, which insulates revenue of the Group. Merchant power sale has witnessed lower demand due to economic slowdown, and consequential impact on tariff. Based on the present assessment, the Management does not expect any medium to long-term impact on the businesses of the Group. The Group has evaluated the possible effects on the carrying amounts of property, plant and equipment, goodwill, inventory, loans and receivables basis the internal and external sources of information and concluded, exercising reasonable estimates and judgements, that the carrying amounts of these assets are recoverable. Having regard to the above, and the Group's liquidity position coupled with expected future cash flows, there is no uncertainty in meeting financial obligations in the foreseeable future. The impact of COVID-19 may differ from that estimated as at the date of approval of these financial results

- The Code on Social Security, 2020 ('the Code') received presidential assent on September 28, 2020. The Ministry of Labour and Employment, released the draft rules of the Code on November 13, 2020. however, the date on which the Code will come into effect has not yet been notified. The Group will assess and record the financial impact of the Code in the period(s) when it becomes effective.
- 3 During the quarter ended June 30, 2021:
- a) JSW Hydro Energy Limited, a wholly owned subsidiary of JSW Energy Limited, has raised ₹5,162.87 crore [US\$ 707 million] by issuing of US\$ denominated senior secured "Green Bonds" (also referred as the notes) pursuant to Rule 144A of the U.S. Securities Act, 1933, as amended, and applicable Indian regulations, and repaid its existing green project related rupee-denominated indebtedness. The notes are listed on the Singapore Exchange Securities Trading Limited (SGX-ST).

- b) The Group has transferred 18 MW thermal power plant project at Salboni in West Bengal to JSW Cement Limited for ₹ 95.67 crore on going concern basis. There was no material impact of the same on the financial results.
- c) Some of the existing customers of the Parent Company having long term power purchase agreements had entered into long term job work agreements for supply of power starting from July 1, 2020. As per the said agreements, the coal required for power generation is supplied by the respective customers which is converted into power by the Parent Company and supplied to the customers. The Parent Company receives the job work charges from the customers. These arrangements have resulted in lower 'Revenue from operations' and correspondingly 'Fuel cost'. In view of the foregoing and to such extent, the results for the quarter ended June 30, 2021 is not fully comparable with those for the the corresponding previous quarter.
