Tata Steel Mining and Jindal Stainless sign MoU for a unique partnership for mining of common boundary in Sukinda

Bhubaneswar, July 19, 2021:

Tata Steel Mining Limited (TSML) and Jindal Stainless Limited (JSL) signed a MoU on July 16, 2021 to jointly unearth the Chrome Ore locked up in the boundary between their mines located in Sukinda of Jajpur district, Odisha.
