शहराहापुर, 13 अगस्त (जनसंता)। हत्या के मुकदमे में अपर सत्र न्यायाधीश विद्यार्थी कु ने चार अभियुक्तों को आजीवन कारावास की सजा सुनाई उन्होंने दो अभियुक्तों पर एक-एक लाख रुपए सजा अभियुक्तों पर 50-50 हजार रुपए का जुर्माना भी लगाया शहर के चौक कोतवाली के मुद्दाला इयातुगु निय परमप्रभ खसरेन ने बताया कि उनके मामा संयुद्धाल लॉ के। 14 मई 2015 को मामा ने फोन करते उन्हें घर बुला इसके बाद सलीम नाम का एक व्यक्ति मामा के घर आ बताया कि उसकी पत्नी को तबीयत खराब है। शाम छह 1 यह अपने मामा के साथ जुम्हारी वाली गली पहुंचे तो व्यक्ति आ गया। उन्हें वहां खड़ा करके मामा को अपने र ले गया। परमप्रभ ने बताया कि काफी देर बाद जब उन मामा को फोन की तो उन्होंने बताया कि वह बड़ा ककरा कब्रिस्तान में धाबल पड़े हैं। सलीम खां ने उन्हें गोली मार है। चौके पर पहुंचकर उन्होंने मामा को अस्पताल में 1 करवाया। इस मामले में अगले दिन रिपोर्ट दर्ज कराया। 18 को उनका निधन हो गया। पुलिस ने संयुद्धाल के मुद्दु बखल के आधार पर हत्यारों के अनाद, कलक्टर, खेसरे किल्ली के ही माय मुद्दखानी निवासी लंदन के खिल रिपोर्ट दर्ज कर ली। जांच में पता चला कि लंदन में एक नाम बताकर फोन की थी। उसने संयुद्धाल के घर कलक्टर के कहने पर रुपए लेकर गोली मारी थी। कलर जमीन पर कहरा करने के लालच में चाचा की हत्या कर चाहा था। परमप्रभ को तबारी के आधार पर पुलिस ने रु व आजाद को भी नामजद किया था। जांच के बाद चारों खिलाफ आरोपचर कोर्ट में पेशिल नियर।

**25 पेपर मिलों पर लगाया जुर्माना**

मुजफ्फरनगर, 13 अगस्त (जनसंता)। जनपद में प्रदूषण विभाग ने चौबीस पेपर मिलों पर कर रुपए का जुर्माना लगाया है और तीन फैक्टरीयों को बंद कर दिया है। खलीली में दो व मौरपुर में एक फैक्टरी में लाइसेंस के चल रही थी जो मैट्री के लेड को गलतकर रं बना रही थी। प्रदूषण नियंत्रण अधिकारी अमित सिंह के नेर में प्रदूषण फैलाने वाली तीन फैक्टरीयों के बिरुद्ध कार्रवाई गई है। इसके अलावा प्रदूषण नियंत्रण विभाग की टीम फैक्टरीयों के वायुजद प्रदूषण फैलाने से बचाने व आने वाले पेपर मिलों पर भी करोड़ों रुपए का जुर्माना लगाया है।
