In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform that the Company has received Income Tax Refund Order from the Office of Deputy Commissioner of Income Tax Cir-3(1)1) Bengaluru vide F.No. ITAT OGE/DCIT/C-3(1)(1)/2022-23 dated 30.11.2022 (received today) u/s 254 of the Income Tax Act-1961 for the Assessment Yeas 2011-12.

- 2. The said order was passed allowing R&D Expenditure of Rs.595.23 Crs as capital expenditure, resulting in refund of Rs.427.45 Crs. The said refund includes interest of Rs.176.93 Crs.
- 3. The said order was passed in compliance with the order passed by the Income Tax Appellate Tribunal (ITAT) in favour of HAL in the dispute pertains to allowing R&D Expenditure as capital expenditure while computing taxable profit under Sec 35(1)(iv) of the Income Tax Act-1961, which was disallowed by the Income Tax Authorities during the assessment.
