SUB.: Scrutinizer's Report on Postal Ballot process conducted through electronic voting system in accordance with the provisions of Section 108 and Section 110 and other applicable provisions, if any of the Companies Act, 2013 read with Rule 20 and Rule 22 of Companies (Management and Administration) Rules, 2014, as amended and MCA Circulars.

My responsibility as Scrutinizer is restricted to ensure that the Postal Ballot (remote e-voting) process is conducted in a fair and transparent manner and to issue the Scrutinizer's Report on the votes cast "FOR" or "AGAINST" the resolutions stated in the Postal Ballot Notice, based on the Reports generated from the E-voting system provided by Link Intime India Private Limited, the Authorized Agency to provide remote e-voting facilities, engaged by the Company.

I submit my Report as under:

- 1. The Notice dated November 15, 2024 was sent to the shareholders electronically in respect of the resolutions mentioned in Notice of Postal Ballot passed by Postal Ballot (remote e-voting).
- As per the MCA Circulars, physical copies of the Notice, postal ballot forms and pre-paid Business Reply Envelopes were not dispatched to Members for this Postal Ballot. Accordingly, the communication of the assent or dissent of the members had taken place through the remote evoting system only.
- 3. The Company had availed the services offered by Link Intime India Private Limited for conducting postal ballot through remote e-voting by the Shareholders of the Company.
- 4. The Remote e-voting period commences on Monday, November 18, 2024 at 9:00 a.m. (IST) and ends on Tuesday, December 17, 2024 at 5.00 p.m. (IST) and the Link Intime India Private Limited e-voting platform was blocked thereafter.
- 5. The shareholders of the Company holding shares either in Physical form or in Dematerialized form, as on the "cut-off" date of Friday, November 08, 2024, were entitled to vote on the resolutions as contained in the Notice of Postal Ballot.
- 6. Pursuant to Provisions of the Companies Act, 2013 and MCA Circulars issued by Ministry of Corporate affairs, the Company has sent Postal Ballot Notice(s) to the Members whose name(s) appeared in the Register of the Members/ List of Beneficial Owners received from Central Depository Services (India) Limited (CDSL) as on the "cut-off" date of Friday, November 08, 2024

and whose email IDs was/were available with the Company and Depositories through electronic means only and the Company has not dispatched physical notices to any Members.

- 7.
