Trump picks reflect his priorities

WASHINGTON

A week after Donald Trump won a second-term in the White House, the contours of his new presidency have started taking shape.

The President-elect has announced nearly a dozen appointees, the first steps toward filling out his White House staff and key government departments. He also made comments to the media and on social media that highlight what his priorities will be upon taking office in January, with a special focus on immigration and foreign policy.

After a sometimes chaotic start to his first term, Trump is laying the groundwork for his next administration with a more clearly defined plan and personnel ready to enact it.

John Ratcliffe

President-elect Donald Trump on Tuesday announced that former Director of John Ratcliffe National Intelligence will head the Central Intelligence Agency (CIA) under his administration. "From exposing



fake Russian collusion to be a Clinton campaign operation, to catching the FBI's abuse of Civil Liberties at the FISA Court, John Ratcliffe has always been a warrior for Truth and Honesty with the American Public," Trump said. "When 51 intelligence officials were lying about Hunter Biden's laptop, there was one, John Ratcliffe, telling the truth to the American People," he added.

"For these and many other reasons, it was my great honour in 2020 to award John the National Security Medal, the nation's highest honour for distinguished achievement in the field of Intelligence and National Security," the President-elect said.

Ratcliffe previously served as the sixth director of National Intelligence (DNI). In this role, he served as the leader of the US

intelligence community and principal intelligence advisor to President Trump in his first term.

"Look forward to John being the first person ever to serve in both of our nation's highest Intelligence positions. He will be a fearless fighter for the Constitutional Rights of all Americans, while ensuring the Highest Levels of National Security, and PEACE THROUGH STRENGTH," Trump said. Prior to his nomination and confirmation as DNI, Ratcliffe served in Congress for over five years as

the US Representative for the 4th Congressional District of Texas. As a Congressman, he was a leading policy maker on national security issues as a member of the House Intelligence and Judiciary Committees and as Cyber-security Chairman on the Homeland Security Committee.

Kristi Noem

Trump selected Governor Kristi Noem of South Dakota on Tuesday to run the Homeland Security Department, a critical position in charge of the nation's

immigration system.

Trump has made an immigration crackdown a central element of his administration's promises, with pledges to not only more aggressively police the border but to also carry out a wide-scale deportation operation throughout the country. Noem will play a crucial role in helping Trump deliver on those promises as she will be in charge of agencies that enforce immigration laws, including US Immigration and Customs Enforcement and US Customs and Border Protection.
