We wish to inform you that the Certified Copy of the Order passed by the NCLT has been received by the Company on 10th January, 2020 and the same has been filed by the Company with the Registrar of Companies, Maharashtra, Mumbai, electronically in e-Form INC-28 today i.e. on 1st February, 2020. Metahelix Life Sciences Limited has also filed e-Form INC-28 with the Registrar of Companies, Karnataka on 10th December, 2019.

Thus, the Scheme has become effective on 1st February, 2020, being last of the dates on which the Certified Copy of the Order passed by the NCLT has been filed with the Registrar of Companies, Maharashtra, Mumbai and accordingly, Metahelix Life Sciences Limited has merged with the Company effective the said date. The Appointed Date of the Scheme is 1st April, 2019.
