Metahelix Life Sciences Limited has also filed e-Form INC-28 with the Registrar of Companies, Karnataka on 10<sup>th</sup> December, 2019.

Thus, the Scheme has become effective on 1<sup>st</sup> February, 2020, being last of the dates on which the Certified Copy of the Order passed by the NCLT has been filed with the Registrar of Companies, Maharashtra, Mumbai and accordingly, Metahelix Life Sciences Limited has merged with the Company effective the said date.
